## CARBON COUNTY WEED AND PEST CONTROL DISTRICT

Pursuant to the Wyoming Weed and Pest Control Act (W.S. 11-5-101 through 11-5-201) notice was given to solicit nominations for two appointments to the Carbon County Weed and Pest Control District.

Requirements having been met, and two nomination petitions having been received by the Board of County Commissioners, a motion was made by Lemich and seconded by Grieve to appoint Steve Adams, Baggs, Wyoming for Director for a four year term in Area V and to appoint Gary Vivion, Leo Route, Hanna, Wyoming for Director for a four year term in Area II.

## OLD STATE PENITENTIARY

A motion was made by Lemich and seconded by Grieve to give approval for partial funding, not to exceed \$12,500.00, for a site design to be done in co-operation with the City of Rawlins and the State of Wyoming on the Old State Penitentiary property and to pursue the formation of a Joint Powers Board with the City of Rawlins.
