Barbara Herring and Blanche McNamara, representing the Carbon County Senior Services Board of Directors, presented to the Commissioners for their approval, the decision of the Senior Board to reorganize the staff positions of the Carbon County Senior Services Program as follows: Executive Director, Nutrition Coordinator, Bookkeeper and Site Manager (Rawlins). The Commissioners were in agreement with the decision.

CARBON BUILDING - STATE LEASE

A motion was made by Lemich, seconded by Grieve and unanimously carried to renew the lease with the State of Wyoming for office space located in the Carbon Building 3rd Street and Buffalo, Rawlins, Wyoming, 82301. 846.38 square feet to be occupied by Vocational Rehabilitation; 944.19 square feet, Revenue Department - Motor Vehicle Division; 4372.85 square feet, Department of Health & Social Services, Division of Public Assistance; 293.50 square feet, Education Department and 1103.20 square feet to be occupied by Probation and parole. 7,560.12 total square feet for the sum of \$56,322.89.

CARBON COUNTY COURT

A motion was made by Lemich, seconded by Grieve and unanimously carried to execute the following agreement:

AGREEMENT

THIS AGREEMENT is made and entered into to be effective the 15th day of February, 1983, by and between the County of Carbon, a Wyoming political subdivision, acting by and through its duly authorized Board of Commissioners, and the Town of Hanna, a Wyoming municipal corporation situate in Carbon County, Wyoming, acting by and through its Mayor and Town Council.

W-I-T-N-E-S-S-E-T-H .

WHEREAS Carbon County maintains a County Court system under the authority granted in Chapter 5, Title 5, Wyoming Statutes (1977) and requires the use of courtroom facilities in the Town of Hanna to conduct County Court business; and

WHEREAS the Town of Hanna has courtroom facilities available in which it operates a municipal court and has a need for an alternate Municipal Judge;

NOW, THEREFORE, the parties agree as follows:

1. Carbon County shall be permitted to make use of the courtroom facilities within the Town of Hanna on a continuing basis according to a schedule arranged between the County Court Judges and the Municipal Judge, in advance, for the conduct of County Court business.
2. The County Court Judges of Carbon County shall act as needed and when requested and scheduled as alternate Municipal Justices in the Municipal Court of the Town of Hanna.
3. This agreement may be terminated by either party on thirty (30) days notice.

IN WITNESS WHEREOF the parties have hereunto set their hands and seals to be effective the day and year first above written.
