FLOODPLAIN RESOLUTION

A motion was made by York, seconded by Lemich and unanimously carried to adopt the following amendment relating to the Flood Damage Prevention Resolution on file in the office of the County Clerk.

RESOLUTION 1984 - 5

WHEREAS, On the second day of November, 1983, the Board of County Commissioners of Carbon County, Wyoming adopted a floodplain resolution, which resolution for implementation required the approval of the Federal Emergency Management Administration, and

WHEREAS, said agency has requested three modifications in said resolution;

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Carbon County, Wyoming as follows:

Section 1: Resolution No. 1983-11 adopted by the Board of County Commissioners on the second day of November, 1983 be, and the same is hereby amended as follows:

(a) Section 7b(3) (b) is hereby amended and reenacted to read as follows: "(b) If the development is not a mobile home and is new construction or substantial improvement of any other residential structure, the development permit shall be issued requiring compliance with Section 8. After completion of the structure, a certificate in writing by a licensed professional engineer or architect shall be furnished by the applicant to the Office of Planning and Development certifying that the lowest floor, including basement, is elevated to or above base flood elevation."

(b) Section 7b(3) (c) is hereby amended and reenacted to read as follows: "(c) If the development is nonresidential, new or substantial improvement of any commercial, industrial or other non-residential structure, the development permit shall be issued required compliance with Section 8. After completion of the structure a certificate in writing by a licensed professional engineer or architect shall be furnished by the applicant to the Office of Planning and Development certifying that the structure either has the lowest floor, including basement, elevated to the level of the base flood elevation, or, together with attendant utility and sanitary facilities, shall:

(i) be floodproofed so that below the base flood level the structure is watertight with walls substantially impermeable to the passage of water, and

(ii) have structural components capable of resisting hydrostatic and hydrodynamic loads and affects of buoyancy."

(c) There is hereby created a Section 7b(3) (d) of the said floodplain resolution to read as

follows: "(d) No permits for mobile homes shall be issued in an area of special flood hazard."

Section 2: The remainder of Resolution 1983-11 shall remain in full force and effect.

Section 3: This Resolution shall become effective May 1, 1984.

BAGGS EMERGENCY ASSISTANCE

A motion was made by York, seconded by Lemich and unanimously carried to grant financial aid in the amount of \$10,000.00 to aid the Baggs area through the Soil Conservation Service in their effort to help alleviate flood damage to public and private property. Because of the expected high runoff in May and June the situation may be critical.

COUNTY ROAD 605

Vacation procedures for 2 miles of County Road 605 will be delayed until the BLM has completed the Bridger Pass Road. Upon notification by the BLM that the Bridger Pass Road is complete, the Commissioners will remove the motion to vacate the 2 miles of County Road 605 from the table and proceed with the vacation procedures.

WESTERN WYOMING FAMILY PLANNING

Patricia Chopp with Western Wyoming Family Planning submitted a budget request for \$18,796.00 for the 1984-1985 fiscal year.

The Commissioners will take the request under advisement.


