BIG BROTHERS/BIG SISTERS OF CARBON COUNTY

A motion was made by York, seconded by Lemich and unanimously carried to execute the following contract:

CONTRACT

THIS document represents a sub-contract between the Carbon County Commissioners and the service provider, Big Brothers and Big Sisters of Carbon county, Inc., the Carbon County Commissioners having previously contracted for Juvenile Community Alternative Services monies with the Division of Community Programs, Department of Health and Social Services, (Reference: Contractual agreement No. 016-JCA-84-1).

RESPONSIBILITIES of Big Brothers and Big Sisters of Carbon County are as follows:

- A. To deliver services as proposed in the Carbon County Juvenile Community Alternatives Program, a copy of which is attached to this contract and incorporated herein by this reference.
- B. To administer the expenditure of monies provided under this contract in accordance with the general rules and regulations of the Division of Community Programs, Department of Health and Social Services, as well as the specific rules of the Division of Community Programs pertinent to the Juvenile Community Alternative Programs.
- C. To make financial and performance reports to the County Commisisoners pursuant to the rules cited above.
- D. To allow on site monitoring of the program by the Division of Community Programs pursuant to the Division's rules, as well as such monitoring by the Carbon County Commissioners within their discretion.

RESPONSIBILITIES of the Carbon County Commissioners are as follows:

- A. To advance payment to Big Brothers and Big Sisters of Carbon County, Inc. in the maximum amount of this contract, upon receipt of those funds from the Division of Community Programs; Department of Health and Social Services.

MAXIMUM payment under this contract is Six Thousand Five Hundred and Forty-three Dollars and thirty-five cents (\$6,543.35).

MODIFICATION of/or assignment of any provision of this contract shall be valid only when it has been written, signed, and attached to the original of this contract and approved by the Carbon County Commissioners.

PERIOD of performance of this contract shall be for the period March 1, 1984 through June 30, 1984. The provider, Big Brothers and Big Sisters of Carbon County, Inc., understands and agrees that during the period of performance of this contract it is an independent contractor to whom no health/hospitalization benefits, group life insurance, personal indemnity, and similar benefits available to County employees will accrue.
