1% SALES & USE TAX COMMITTEE

Members of the Committee to pass the 1% Sales & Use Tax, which will appear on the General Election Ballot, met with the Commissioners. The Commissioners asked that the towns in Carbon County disclose what the money will be used for and make assurances that it will be used for the specified purpose.

CARBON COUNTY SCHOOL DISTRICT #1

Dr. Reginald S. Nolin met with the Commissioners to introduce himself as the new Carbon County School District #1 Superintendent.

CARBON COUNTY - DIXON AIRPORT

A motion was made by Lemich, seconded by York and unanimously carried to execute a Preapplication for Federal Funds for the Dixon Airport. The request for financial assistance seeks Federal Aid in the cost of the following items of development for the Dixon Airport:

1. Rehabilitate and Mark Existing Runway 6/24 4,800 Feet x 50 Feet and Widen to 60 Feet Including Grading to meet FAA requirements.
2. Rehabilitate Existing Connecting Taxiways and Apron Areas.
3. Bury Existing Powerline on the Southwest End of Runway 6/24.
4. Install medium intensity runway lighting on runway 6/24. Install lighted wind cone, segmented circle and airport rotating beacon.

CARBON COUNTY ROAD NO. 351 SEMINOE

Dave Wilde with the U.S. Bureau of Reclamation met with the Commissioners for further discussion relating to the problems on the Seminoe Road.

CARBON COUNTY SHERIFF - US FOREST SERVICE

A motion was made by York, seconded by Lemich and unanimously carried to execute the following Operating and Financial Plan:

OPERATING AND FINANCIAL PLAN

REIMBURSABLE SERVICES REQUESTED BY FOREST SERVICE

This plan, made and agreed to this 1st day of October, 1984 for the period beginning October 1, 1984, and ending September 30, 1985, by and between the Service and the Sheriff, Carbon County, Wyoming, becomes a part of the agreement between said parties dated June 20, 1981.

A. The Sheriff, Carbon County, Wyoming agrees:

1. The sheriff agrees to assign a vehicular patrol on the Medicine Bow National Forest in the areas listed on the attached schedule. These patrols can be rescheduled or deleted as determined by the designated Forest Officer. The patrol schedule is subject to the availability of funds.
2. When requested by the Service, the sheriff agrees to dispatch additional deputies within his manpower capabilities to unforeseen emergency situations.
3. Sheriff or personnel assigned duties in items 1 and 2 above will be regular employees of the Carbon County Sheriff's department.
4. To procure the following equipment for carrying out the activities of the plan.

It is estimated the useful life of this equipment is three (3) years.

Sheriff, Carbon County, Wyoming, shall be responsible for the maintenance and repair of the above item.

- 5. To furnish the Service itemized statements quarterly on the forms provided by the Service, for the expenditures in Clauses A-1 through A-3 above. The statement should be sent to Forest Supervisor, Medicine Bow National Forest, Laramie, Wyoming.
- 6. To furnish the Service a quarterly report of law enforcement activities relating to (1) Patrols made and miles traveled, (2) Manhours worked, (3) Arrests on federal lands, misdemeanors and felonies, (4) Incidents investigated or responded to including search and rescue, (5) Assistance given to Service personnel.
- 7. To impound abandoned property including vehicles, trailers and other wheeled or tracked vehicles for transportation of the property from the National Forest. This action will be at the request of the Service.

B. The Service agrees:

- 1. To loan the Sheriff, Carbon County, Wyoming, equipment as needed and when mutually agreed to. A list of such equipment will be attached to this plan as Schedule B. While in the possession of the Sheriff, Carbon County, Wyoming, maintenance of this equipment will be the responsibility of the Sheriff, Carbon County, Wyoming, and it will be returned in the same condition as taken.
- 2. To reimburse the Sheriff, Carbon County, Wyoming, on receipt of satisfactory statements of expenditures in accordance with the following schedule, but not to exceed \$7,800.00 for the period established for this plan. Reimbursement for costs associated with removal of impounded property will be made by the Forest Service to the Sheriff, Carbon County, Wyoming, upon receipt of satisfactory statements of expenditure. Impound expenditures shall be kept separate from other statements for patrol and unforeseen emergency requests.

RATE SCHEDULE FOR REIMBURSABLE SERVICES

For the services in Items A, 1 and 2 above the Service agrees to reimburse the cooperator at the rate of \$7.50 an hour per deputy and \$.36 a mile for vehicle mileage. It is mutually understood that no reimbursement will be made for search and rescue activities conducted in conjunction with or a part of this joint operating and financial plan. It is estimated that the total expenditure for services listed in Items A, 1, 2 and 6 above will be approximately \$7,800.00 per year. This shall include approximately \$300.00 for Item A6 described above.
