A motion was made by Lemich, seconded by York and unanimously carried to approve Right of Way Easements from Palm Livestock & Company, Paul Jay Seiersen, and Double Eight Land Corp., aka G. Preston Williams to Carbon County for the purpose of realignment of Carbon County Road No. 404. Easements will be placed on record in the office of the County Clerk.

OCTOBER 3, 1984

The Board met at 10:00 A.M. Commissioners Robert Grieve, James A. York and Emil Lemich were present. Robert Grieve, Chairman.

CARBON COUNTY LIBRARY BOARD

The Commissioners accepted the resignation of Clyde Chapman from the Library Board effective October 1, 1984.

A motion was made by Lemich, seconded by York and unanimously carried to appoint Gary Graalman to fill the unexpired term of Clyde Chapman beginning 10/1/84 and ending 7/1/85.

CARBON COUNTY HEALTH INSURANCE

A motion was made by Lemich, seconded by York and unanimously carried to provide coverage under the existing County Insurance Policy for Human Organ Transplants. The monthly rate is \$.45 per single employee and \$1.50 per employee and family.

CARBON COUNTY ROAD NO. 351

A motion was made by Lemich to move that the County Attorney's Office draft and file the appropriate legal proceedings including Federal Tort Claims Act claim and the lawsuit to recover for Carbon County the damage to Carbon County Road No. 351 which was caused by overloaded trucks using such road. The suit will name as defendants the United States Department of the Interior, Ken Christiansen Painting, Inc., and C & M Ready Mix, and will be for the value of restoring 27 miles at an estimated cost of \$80,000.00 per mile.

The motion was seconded by York. Roll was called with the following results: Grieve, Aye; Lemich, Aye; York, Aye.

CARBON COUNTY PLANNING & DEVELOPMENT

A motion was made by Lemich, seconded by York and unanimously carried to approve Case No. 84-15.

Case No. 84-15 - Zone Change - David Calvert, P. O. Box 56, Alcova, WY 82620. Zone change from RAM (Ranching, Agriculture, Mining) to RD-20 (Residential Development) to allow for the development of two residences on a 40 acre parcel of land legally described as in the SE $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 21, Township 28 North, Range 83 West, Carbon County, Wyoming.

Roll was called with the following results: Grieve, Aye; Lemich, Aye; York, Aye.

A motion was made by York, seconded by Lemich and unanimously carried to approve Case No. 84-19.

Case No. 84-19 - Zone Change - David L. Brown, Star Route, Box 12, Riverside, WY 82325. Zone change from RAM (Ranching, Agriculture, Mining) to RB (Retail Business) to allow for a welding supply retail distributor business on approximately three (3) acres of land legally described as in the NW $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 6, Township 14 North, Range 83 West, Carbon County, Wyoming.

Roll was called with the following results: Grieve, Aye; Lemich, Aye; York, Aye.

A motion was made by Lemich, seconded by York and unanimously carried to approve Case 84-20 providing that the Carbon County Flood Plain Regulations are strictly followed and that a septic tank system is used.

Case No. 84-20 - Zone Change - Tom W. Spain, 2021 Weld County Road 27, Ft. Lupton, CO 80621. Zone change from RAM (Ranching, Agriculture, Mining) to RD-20 (Residential Development) to allow for placement of one (1) recreational residence on a parcel of 31.189 acres of land legally described as in the SE $\frac{1}{4}$ of Section 33, Township 19 North, Range 85 West, Carbon County, Wyoming.

CARBON COUNTY FIRE DEPARTMENT

No bids were received for a 4 wheel drive chassis and regular cab with utility bed as called for on Sept. 11, 18, 25, 1984. Bid specifications will be delivered to Carbon County dealers. Any bid received will be opened at the October 16, 1984 Commissioners meeting.
