CARBON COUNTY REGIONAL CHILD DEVELOPMENT PROGRAM

Members of the Carbon County Regional Child Development Program including members from Hanna, Saratoga and Rawlins met with the Commissioners to discuss future budget needs and requests for permanent facilities.

A motion was made by York, seconded by Lemich and unanimously carried to fund a Special Education Aide in the amount of \$1,550.40. The aide will be located in Rawlins.

CARBON COUNTY PUBLIC HEALTH NURSE

Sherri Patch, Public Health Nurse presented a report of the department to the Commissioners.

CARBON COUNTY ROAD AND BRIDGE

A motion was made by York, seconded by Lemich and unanimously carried to accept the low bid from Motorola for a base radio station to be installed at Separation Peak. The amount of the bid is \$7,370.00.

A motion was made by York, seconded by Lemich and unanimously carried to call for bids for two mobile radios.

CARBON BUILDING

A motion was made by Lemich, seconded by York and unanimously carried to renew the lease with the State of Wyoming for the rental of space in the Carbon Building at the current rate of \$28,161.44 every six months.

CARBON COUNTY PLANNING & DEVELOPMENT


A motion was made by Lemich, seconded by York and unanimously carried to lift the moratorium which prohibited the development of County Subdivisions.


CARBON COUNTY ECONOMIC DEVELOPMENT
