Your request for permission to install an 8" sewer line along or across County Highway No. 504 at Saratoga, Wyoming is granted when properly signed below by the Carbon County Engineer or his authorized agent.

This work shall be completed within(30 day period will start when construction begins) from the issue date. No work shall be allowed on Saturdays and Sundays. Extensions will be considered upon request.

IT IS UNDERSTOOD that the Permittee will cause installation at no expense whatsoever to Carbon County and the Permittee will own and maintain the same after installation.

The 8" sewer line shall be installed beneath the surface the surface of the right-of-way at a minimum cover of 36 inches and the disturbed portion of the right-of-way shall be restored to its original condition. All backfilling shall be in eight inch lifts and mechanically compacted to 95% of Standard Proctor.

This work must be accomplished in accordance with accepted good practices and conform to the recommendations of the National Electric Safety Code and to such statutes as are applicable.

Construction warning signs, conforming to the Uniform Traffic Control Device Manual and to the Supplement, shall be in place daily prior to starting any work. If proper signs are not in place during any work, the County Engineer or his authorized agent shall immediately stop all work until proper signs are in place.

Traffic shall be maintained on all roads at all times. Flagmen shall be provided at any locations where the orderly flow of traffic is interrupted.

The Permittee shall maintain the installation at all times and agree to hold Carbon County, Wyoming, the agencies thereof, and their officers and employees harmless from any and all loss and damage or any claims which may rise out of or be connected with the installation, maintenance, alteration, removal or presence of the installation herein referred to or any work or facility connected herewith, within the area covered by this permit.

If it becomes necessary to change the location of the proposed line, written approval must be secured from the County Engineer.

Permittee will be required to shut off lines and remove all combustible materials from the County right-of-way when requested to do so by Carbon County, Wyoming, because of necessary highway construction or maintenance operations.

Permittee shall mark this installation with markers acceptable to Carbon County, Wyoming, a minimum of two signs per mile, and shall be marked by two signs at each bridge or ditch crossing, and at each road crossing.

In the event any changes are made to this roadway in the future that would necessitate removal for relocation of this installation, Permittee will do so promptly at its own expense upon written request from Carbon County, Wyoming. Carbon County, Wyoming, will not be responsible for any damage that may result in the maintenance of the highway or to the installation placed inside County right-of-way limits.

RESOLUTION 1984 - 3

WHEREAS, Carbon County, Wyoming has implemented a zoning and subdivision resolution in accordance with the statutes of the State of Wyoming, and

WHEREAS, both of said resolutions provide for enforcement by criminal penalties for violation of the resolution and the State law also provides for criminal prosecution for violation of these regulations, and

WHEREAS, Carbon County, Wyoming has in the past experienced difficulty with violations of these resolutions and continues to do so at this time, and

WHEREAS, it is the intent of the Carbon County Commissioners to implement a system for dealing with violations of the subdivision and zoning resolutions,

NOW, THEREFORE, in consideration of the premises, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF CARBON COUNTY, WYOMING, as follows:

1. It shall be the duty of the Planning and Zoning Administrator of Carbon County, Wyoming, to investigate potential violations of the Carbon County Zoning and Subdivision Resolution and to report such potential violations to the Carbon County Planning Commission.

2. The Carbon County Planning Commission shall consider all reports of such suspected violations, and if it concludes that there is reasonable grounds to believe that violations have in fact occurred, the Planning Commission shall direct the Administrator to issue notices of violation and cease and desist orders. Such notices and orders shall provide that the suspected violator immediately cease any further actions in violation of the subdivision or zoning resolution and shall also direct the suspected

violator to contact the Administrator within a period of fifteen (15) days from receipt of the notice. If it concludes that there is reasonable grounds to believe the violations were willful, the Planning Commission shall direct the Planning Director to seek fees in accordance with Schedule "A". A copy of the notice to be used by the Administrator is attached hereto as Exhibit "B".

3. In the event the violation is not corrected as set forth in the initial notice of violation or any extentions thereof, or the appropriate fee is not paid, the matter shall again be considered by the Planning Commission and if deemed appropriate the Planning Commission shall direct the Administrator to refer the matter to the County Attorney's Office for consideration of criminal prosecution.
