CARBON COUNTY BOARD OF EQUALIZATION

Having heard Kenneth Y. Knight on behalf of Sinclair Oil Corporation on the June 18, 1985 Board of Equalization hearing, a motion was made by Daily and seconded by York to make the following adjustment on the value of the Sinclair Wyoming Refinery: The value will remain the same on the buildings and improvements. The index factor used by the state concerning the machinery and equipment is excessive due to the economic situation in Carbon County and will use the original installed costs, thereby granting a reduction of \$9,062,443 off of the current estimated fair value of \$74,352,576, for a new value of \$65,290,133.

Roll was called with the following results: Grieve, Aye; York, Aye; Daily, Aye.

CARBON COUNTY PUBLIC HEALTH

A motion was made by York, seconded by Grieve to execute a contract from July 1, 1985 to June 30, 1986 between Carbon County and the Northwest Colorado Visiting Nurse Association, a non-profit association incorporated in Colorado to furnish public health and home health nursing services in conformance with State of Wyoming Standards for an area in Wyoming, surrounding and including the communities of Baggs, Dixon, and Savery. These services will be provided an average of two and one half days a week during this contract. The contract is on file in the office of the County Clerk.

CARBON COUNTY RECREATION BOARD

A motion was made by Daily and seconded by York to reappoint Robert Grieve to a three year term beginning July 1, 1985 and ending June 30, 1988.

CARBON COUNTY SENIOR SERVICES BOARD

A motion was made by Daily and seconded by York to accept with regret the resignation of Nordahl Kirkeeng.

A motion was made by Daily and seconded by York to appoint Ted Prosen for the unexpired term of Nordahl Kirkeeng. The term will begin June 18, 1985 and end March 1, 1987.

CARBON COUNTY ROAD & BRIDGE

A motion was made by Daily and seconded by York to enter into the following contract agreement:

CONTRACT AGREEMENT

Project #: 585-701(1)

Ton Mile Haul

This Agreement entered into this 12th day of June, 1985, by and between the Carbon County Board of County Commissioners (owners) and C. J. Abbott, Inc..

The Contractor agrees to perform the necessary work to complete the loading and hauling of 60,000 tons of crushed gravel surfacing from a stockpile at the Russell Pit, Dixon, Wyoming to Carbon County Road 701 (Dad-Wamsutter Road).

The work is to include the loading and hauling of the material to Road 701 and dumping the material in a windrow as per the district Supervisor's instructions. Carbon County Forces will lay, water and compact the material.

The work to be performed under this Agreement shall commence within ten (10) days after written notice to proceed has been received, and be completed by July 31, 1985.

The owner(s) shall pay the Contractor the total sum of \$221,860.44 subject to additions and deductions by change orders as may be required and upon determination of final quantities.

Progress payments shall be made every month with the payment being 90% of the work completed for the period billed.

Final payment with retainage shall be forty-four (44) days after completion and acceptance by the Carbon County Engineering-Road and Bridge Department, subject to the applicable state law on such disbursements.

CARBON COUNTY SHERIFF


