## SEMINOE ROAD

A motion was made by Daily, seconded by York and unanimously carried to enter into the following agreement:

## A G R E E M E N T

THIS AGREEMENT, made and entered into this date, by and between C.R. Roberts and Sons, Inc., hereinafter referred to as "Company", and Carbon County, Wyoming, a body politic and corporate, hereinafter referred to as "County".

## W I T N E S S E T H;

WHEREAS, the Company wishes to transport up to six (6) loads of equipment from Sinclair, Wyoming to the Seminoe Dam area of Carbon County, and transport said equipment back from the Seminoe Dam area to Sinclair several months later, and

WHEREAS, said loads exceed the weight limitations imposed on that County Road by the County, and

WHEREAS, the County is willing to allow the overloads to be transported over the County Road upon the terms and conditions set forth herein;

NOW, THEREFORE, in consideration of the premises and the mutual covenants and agreements contained herein, IT IS AGREED AS FOLLOWS:

1. The County hereby grants to the Company the right to transport up to six (6) overloads from Sinclair, Wyoming to the Seminoe Dam area, and to remove said overloads of equipment along the same route several months later. The Company agrees to go around any and all cattle guards designated by the Carbon County Road and Bridge Department as being unable to support the equipment. The Company further agrees to restore or pay for any damage to said roads, cattle guards, and fences which are damaged, and any other property of any kind or description, whether publicly or

privately owned, which is damaged as the result of the transportation of the equipment overloads across the County Road.

2. The Company agrees to have a Road and Bridge official of the County of Carbon accompanying them both into the site and arrange for their presence upon the return trip.

3. To secure the Company's restoration or payment for any damage to said road, the Company hereby agrees to post a bond in the amount of twenty-five thousand dollars (\$25,000.00) in favor of Carbon County in a form acceptable to the Carbon County Attorney's Office.

4. The Company agrees to indemnify and save the County harmless from any and all liability which the County otherwise may have as a result of the transportation of the said equipment overloads on the County Road. The Company also agrees to abide by any request of the Road and Bridge official during the use of the County Road named above.

A G R E E M E N T

THIS AGREEMENT, made and entered into this date, by and between CARBON COUNTY, WYOMING a body politic and corporate, acting by and through the Board of County Commissioners of Carbon County, Wyoming, hereinafter referred to as "County", and ALLA REDDY, M.D., of Hanna, Wyoming, hereinafter referred to as "medical doctor",

WHEREAS, the parties to this Agreement have heretofore made and entered into an agreement dated October 4, 1978, pursuant to which the medical doctor has provided medical services and constructed a medical clinic in the Town of Hanna, Carbon County, Wyoming, and the County has provided assistance and guarantees to such medical operation pursuant to a perceived need by the County for such medical services to be available in Hanna, Wyoming, and

WHEREAS, the terms of said agreement have now expired, but the need for such medical services in Hanna, Wyoming continues and the medical doctor desires to continue to provide such services;

NOW, THEREFORE, in consideration of the premises and the mutual covenants and agreements of the parties, IT IS AGREED AS FOLLOWS:

1. Medical doctor agrees to continue to practice medicine in his medical clinic in Hanna, Wyoming throughout the entire term of this agreement, and to use his best professional efforts to provide health care services to patients, and he shall work a minimum of forty (40) hours per week.
2. The County shall pay to medical doctor or his professional Wyoming corporation, the sum of \$1,250.00 per month, which shall commence July 1, 1985, and continue through and including the month of December, 1985.
3. Medical doctor agrees to hold harmless and indemnify the County from any and all liability arising out of the acts of omission and commission of doctor, his employees, agents and staff of the Hanna Medical Clinic during the entire term of this agreement, and such acts shall include professional acts of commission and omission, malpractice, negligence and embezzlement of medical doctor, agents, and his staff.
4. This agreement contains the complete understanding of the parties and shall supersede any and all other agreements between the parties.
