MEDICINE BOW RURAL HEALTH CARE DISTRICT

Pursuant to W. S. 35-2-702 (a), a majority of the qualified electors in the Medicine Bow Rural Health Care District having voted for the establishment of the District, a motion was made by York, and seconded by Daily and unanimously carried to establish said District.

COUNTY ROAD 500

A request was made by Eugene W. and Marilyn M. Walck for the relocation of a portion of County Road 500. The Commissioners have taken the request under advisement.

COUNTY COMMUNICATIONS DEPARTMENT

A motion was made by York and seconded by Daily and unanimously carried to allow Clayton Kilgore, County Communication Technician, to purchase one radio programmer from Commercial Communications in Riverton, Wyoming for use on the Sheriff, Fire Department and Road & Bridge radios. The purchase price is \$3096.00.

CLERK OF THE DISTRICT COURT

A motion was made by York, seconded by Daily and unanimously carried to enter into a cooperative agreement between the Child Support Enforcement Section of Wyoming State Division of Public and Social Services and Carbon County, for the purpose of securing financial support for minor children.

The cooperative agreement is on file in the office of the County Clerk.

BAGGS SOLID WASTE BOARD

A motion was made by York, seconded by Daily and unanimously carried to reappoint Charlotte Corson to a three (3) year term, beginning September 4, 1985 and ending September 4, 1988.

CARBON COUNTY SENIOR SERVICES BOARD

The Commissioners regretfully accepted the resignation of Josephine Salisbury from the Senior Services Board.

A motion was made by Daily and seconded by York and unanimously carried to appoint John Gallenbeck to the unexpired term of Josephine Salisbury. His term will expire March 4, 1988.

COUNTY ROAD 605

The Board of County Commissioners, having been duly notified by the Bureau of Land Management that the Bureau has constructed bridges on the Muddy Creek Road and improved Bridger Pass and Muddy Creek roads to the Bureau's specifications and requirements, have decided to consider vacation of that por-

tion of County Road 605 commencing at the North Section line of Section 28, Township 18 North, Range 90 West of the 6th P.M., Carbon County, Wyoming and running thence in a generally southerly direction and terminating at the North Section line of Section 5, Township 17 North, Range 90 West of the 6th P.M., Carbon County, Wyoming. All objections thereto, or claims for damages by reason thereof, were filed in writing with the County Clerk of Carbon County, Wyoming, before noon on the 3rd day of September, 1985. A continuation of the public hearing held April 4, 1984 was held September 3, 1985 at the hour of 2:00 P.M. in the County Commissioner's Room, Courthouse, Rawlins, Wyoming.

Having considered all objections to the vacation of said portion of County Road 605, a motion was made by York and seconded by Daily to vacate County Road 605 commencing at the North Section line of Section 28, Township 18 North, Range 90 West of the 6th P.M., Carbon County, Wyoming and running thence in a generally southerly direction and terminating at the North Section line of Section 5, Township 17 North, Range 90 West of the 6th P.M., Carbon County, Wyoming.
