CARBON COUNTY MEMORIAL HOSPITAL BOARD


The Commissioners accepted with regret the resignation of Ann C. White-Enlow from the Hospital Board.

Frank Smith, Supervisor gave his semi-monthly report to the Commissioners and three interviews were conducted for shop mechanic.


THERE BEING NO FURTHER BUSINESS, the meeting was adjourned.
