RAWLINS CHAMBER OF COMMERCE

A motion was made by York, seconded by Daily and unanimously carried to lease a building for \$250.00 per month on Seiloff Street for the Coroner office and vehicle.

TOWN OF BAGGS

Lynn Updike, Mayor of Baggs submitted a proposal for additional funds from the county to increase their dispatch service. The request was taken under advisement.

CARBON COUNTY ROAD & BRIDGE

Frank Smith, Road & Bridge Supervisor gave his report to the Commissioners.

Bids for the purchase of regular gasoline and number one and number two diesel fuel will be called for at the November 5, 1985 meeting.

A motion was made by Daily, seconded by York and unanimously carried to purchase road equipment totaling \$205,885.00.

RAWLINS RECREATION CENTER

The Commissioners agreed to a letter of support to be submitted with the city's grant application to the Wyoming Farm Loan Board for funds to build the proposed Rawlins Recreation Center.

The Commissioners favor a recreation center but stated that the city must assume responsibility for the majority of the building costs and operating expenses.

ENCAMPMENT SENIOR CENTER


