CARBON COUNTY FIRE PROTECTION BUDGET

In compliance with the Uniform Municipal Procedures Act, Chapter 4, Section 16-4-133 W.S. 1977, the Carbon County Fire Protection budget will be increased by \$7,556.25 by virtue of Amoco Industrial Revenue Bond fees. Said funds are unanticipated funds and are to be used for fire vehicle and equipment insurance.

Any and all persons were heard with reference to the budgeting of unanticipated funds November 18, 1985 at 10:00 A.M. at a special meeting of the Board of County Commissioners in their office in the Courthouse, Rawlins, Wyoming.

There being no protests, the budget of Carbon County Fire Protection was increased by \$7,556.25.

CARBON COUNTY CORONER

A motion was made by Daily, seconded by York and unanimously carried to execute a lease by and between Kenneth G. Forster and Ronald E. Kelley d/b/a Rawlins Self Storage and Warehouses of Carbon County, lessors and the Board of County Commissioners of Carbon County, lessee for a steel building located on a part of Block eleven (11) in the Industrial Addition to the City of Rawlins, County of Carbon, State of Wyoming for use by the Coroners office. Said lease is on file in the office of the County Clerk.
