LIQUOR LICENSE MORITORIUM

A motion was made by Daily and seconded by Grieve to extend the moratorium on the issuance of new liquor licenses excepting from the moratorium the 24-hour malt beverage permits, for an additional year commencing January 1, 1986 and ending December 31, 1986.

CARBON BUILDING

A motion was made by Daily, seconded by Grieve and unanimously carried to renew the contract for custodial service for the Carbon Building with Nick Rodriguez dba Nick's Cleaning Service.

CARBON COUNTY ROAD & BRIDGE

Frank Smith, Road Supervisor gave his Road & Bridge Department report for the month to the Commissioners.

CARBON COUNTY SHERIFF

A motion was made by Daily and seconded by Grieve to execute an agreement by and between the City of Rawlins and Carbon County to house municipal prisoners in the County Jail facility for \$36.00 per day per prisoner.

ABANDONED MINE LAND PROJECT 7A, HANNA

A motion was made by Daily, seconded by Grieve and unanimously carried to execute a consent for reclamation by the Department of Environmental Quality of Block 2 Lot 1, of the Veterans addition to the Town of Hanna. The property belongs to Carbon County. The consent is on file in the office of the County Clerk.

HANNA MEDICAL CLINIC

A motion was made by Daily and seconded by Grieve to execute an agreement by and between Carbon County and Alla Reddy M.D. to continue to practice medicine in Hanna for an additional six (6) months commencing January 1, 1986 through June 1986 for the sum of \$1250.00 per month. The agreement is on file in the office of the County Clerk.

DESIGNATION OF DEPOSITORYES

A motion was made by York and seconded by Daily and unanimously carried to designate all federal and state chartered banks and savings and loans in Carbon County with FDIC and FSLIC approval as County depositories.

REGION VIII CHILD DEVELOPMENT PROGRAM

A motion was made by Daily, seconded by Grieve and unanimously carried to allow \$1855.70 for a new steel door & a wheel chair ramp to both entrances of the Child Development administrative office in Rawlins.

CARBON BUILDING

The following bid was received for providing and erecting the steel shelving in Room 144, 145, 146 and 147 in the Carbon Building: Saratoga Construction and Electric, Inc. \$13,367.21. There being no other bids, a motion was made by Daily and seconded by Grieve to accept the bid of Saratoga Construction & Electric, Inc.

CARBON COUNTY PLANNING & DEVELOPMENT

A motion was made by Daily and seconded by Grieve to approve Case No. 85-27.

Case No. 85-27 - Variance - Dick Lake, Ft. Steele Route, Rawlins, WY 82301. A variance from the County Zoning Resolution, Section 324.3 (minimum yards) to allow development of a building on a property line on approximately one acre of land legally described as in the NE $\frac{1}{4}$ SE $\frac{1}{4}$  of Section 26, Township 21 North, Range 85 West, Carbon County, Wyoming.

Roll was called with the following results: Grieve, aye; York, absent; Daily, aye.

A motion was made by Daily and seconded by Grieve to table Case No. 85-28.

Case No. 85-28 - Zone Change - Nels Anderson and John Kranich, W296 N7074 Tamron Court, Hartland, WI 23029. A zone change from RAM (Ranching, Agriculture, Mining) to RD-20 (Residential Development) to allow for development of two recreational residences on approximately 51.15 acres of land legally described as the NE $\frac{1}{4}$ SW $\frac{1}{4}$  and Tracts in the SW $\frac{1}{4}$ NE $\frac{1}{4}$  and SE $\frac{1}{4}$ NW $\frac{1}{4}$  of Section 34, Township 19 North, Range 85 West, Carbon County, Wyoming.


A motion was made by Daily and seconded by Grieve to approve Case No. 85-30.

With comments from Mike Young duly noted. Mike Young believes that if the County is going to allow small businesses in residential subdivisions the County should maintain the subdivision roads.


