## CITY-COUNTY AGREEMENT

THIS AMENDMENT to the Rawlins-Carbon County Airport Board City-County Agreement dated this \_\_\_\_ day of \_\_\_\_\_, 1985, by and between the BOARD OF COUNTY COMMISSIONERS of Carbon County, Wyoming, hereinafter referred to as the "County", and the CITY COUNCIL of the City of Rawlins, Carbon County, Wyoming, hereinafter referred to as the "City".

WHEREAS, the County and City have entered into an agreement dated the 4th day of November, 1976, entitled "Rawlins-Carbon County Airport Board City-County Agreement", which agreement provided for the creation of the Rawlins-Carbon County Airport Board; and

WHEREAS, it is now the desire of the Carbon County Airport Board, the City and the County to amend such agreement in the manner hereafter provided.

NOW, THEREFORE, the parties hereto agree that Article 7 entitled "Liability" shall be amended so that from and after the effective date of this agreement, it shall read in its entirety as follows:

## 7.

## LIABILITY

The Board shall carry liability insurance for operation and use of the Airport unless directed not to by both the City and County. No individual member of the Board shall be personally liable for any action or procedure of the Board.
