BOUNDARY BOARD MEETING

The Board met at 11:00 A.M. Members present were: Robert Grieve, James A. York, O. R. "Bud" Daily, Darrell Stubbs and Mary Aydelott.

Petitions were presented by both School Districts One and Two to change existing boundaries as follows:

School District No. One agrees to transfer Sections 11 and 12 of Township 24 North, Range 83 West of the 6th Principal Meridian to Carbon County School District No. Two.

School District No. Two agrees to transfer Sections 29, 30, 21, 32 and 33 of Township 25 North, Range 83 West of the 6th Principal Meridian to Carbon County School District No. One.

John Mac Pherson appeared before the board in favor of the boundary changes.

A motion was made by Stubbs, seconded by Aydelott and unanimously carried to approve the boundary changes.

THERE BEING NO FURTHER BUSINESS, the Boundary Board adjourned.

THE CARBON COUNTY COMMISSIONERS RECONVENED at 11:15 A.M. All present.

TOWN OF ELK MOUNTAIN

A motion was made by Daily, seconded by York and unanimously carried to execute an agreement between Carbon County, Wyoming and the Town of Elk Mountain to allow the Department of Army Engineers to complete necessary repairs along the Medicine Bow River in the town of Elk Mountain. The agreement is on file in the office of the County Clerk of Carbon County.

COURTHOUSE

A motion was made by York, seconded by Daily and passed to accept the low bid of Pancratz Company for the re-roofing of the Carbon County Courthouse in the amount of \$30,500.00

ROAD AND BRIDGE

Frank Smith, Road & Bridge Supervisor presented his report to the Commissioners.

A motion was made by Daily, seconded by York and unanimously carried to execute an application to the Wyoming Farm Loan Board for assistance in the amount of \$876,408.00 to upgrade portions of County Roads 401 and 500.
