A motion was made by Daily, seconded by York and unanimously carried to approve a budget reduction contract between the State of Wyoming and Carbon County for public health nurse services.

Roll was called with the following results: Grieve, aye; York, aye; Daily, aye.

September 3, 1986

A motion was made by Daily and seconded by York to approve Cases No. 86-21, 86-22, 86-24 and 86-25.

Case No. 86-21 - To amend the Carbon County Subdivision Regulations of 1980, specifically Section 1.00, subsection 1.05, "Purpose", to change the wording to conform with the renumbering of Wyoming Statutes.

Case No. 86-22 - To amend the Carbon County Subdivision Regulations of 1980, specifically Section 1.00, subsection 1.07, item 1.07.03, "Unlawful to Divide Without Compliance", to change the wording to conform with the renumbering of Wyoming Statutes.

Case No. 86-24 - To amend the Carbon County Subdivision Regulations of 1980, specifically Section 1.00, subsection 1.18, item 1.18.03, "Amendments to the Subdivision Regulations", to change the wording to conform with State Statutes 18-5-306(a)(x).

Case No. 86-25 - To amend the Carbon County Subdivision Regulations of 1980, specifically Section 1.00, subsection 1.18, item 1.18.04, "Amendments to the Subdivision Regulations", to change the wording to conform with State Statutes 18-5-306(a)(x).

Roll was called with the following results: Grieve, aye; York, aye; Daily, aye.

A motion was made by Daily and seconded by York to approve Case No. 86-23.

Case No. 86-23 - To amend the Carbon County Subdivision Regulations of 1980, specifically Section 1.00, subsection 1.10, item 1.10.02, "Enforcement, Violations, and Penalties", to change the wording to conform with County Resolution 1984-3, dealing in part with fines to be assessed in land use violations.

Roll was called with the following results: Grieve, aye; York, aye; Daily, aye.

A motion was made by Daily and seconded by York to table Case No. 86-26.

Case No. 86-26 - To amend the Carbon County Subdivision Regulations of 1980, specifically Section 2.00, subsection 2.03, item 2.03.01, "Sketch Plan Review", changing the wording to reflect that Planning Commission meeting information may be obtained from the Carbon County Planning and Development office, not County Clerk's office.

Roll was called with the following results: Grieve, aye; York, aye; Daily, aye.

A motion was made by Daily and seconded by York to approve Case No. 86-27.

Case No. 86-27 - To amend the Carbon County Subdivision Regulations of 1980, specifically Section 2.00, subsection 2.04, item 2.04.03, "Preliminary Plan", to add conformance with State Statutes 18-5-306(b), allowing local soil conservation districts 60 days from receipt of plan for review and recommendations.

Roll was called with the following results: Grieve, aye; York, aye; Daily, aye.

A motion was made by Daily and seconded by York to approve Case No. 86-28.

Case No. 86-28 - To amend the Carbon County Subdivision Regulations of 1980, specifically Section 2.00, subsection 2.04, item 2.04.08, "Approval Provisions", to delete the reference to zoning variances allowed only with a Planned Unit Development.

Roll was called with the following results: Grieve, aye; York, aye; Daily, aye.

A motion was made by Daily and seconded by York to approve Case No. 86-29.

Case No. 86-29 - To amend the Carbon County Subdivision Regulations of 1980, specifically Section 4.00, subsection 4.02, item 4.02.03, "Preliminary Plan Requirements", to delete sub-items r)4, 5, and 6 relating to landscaping, and geologic and wildfire reports.

Roll was called with the following results: Grieve, aye; York, aye; Daily, aye.

A motion was made by Daily and seconded by York to approve Case No. 86-30.


Case No. 86-30 - To amend the Carbon County Subdivision Regulations of 1980, specifically Section 4.00, subsection 4.02, item 4.02.05, "Preliminary Plan Requirements", to delete the entire item, which required a wide variety of geologic soils, vegetation, and wildfire analysis, some of which is redundant.

Roll was called with the following results: Grieve, aye; York, aye; Daily, aye.

C.O.V.E.

A motion was made by Daily, seconded by York and carried to approve the C.O.V.E. fiscal year 1986-87 budget request in the amount of \$8,900.00.

THERE BEING NO FURTHER BUSINESS, the meeting was adjourned.
