CARBON COUNTY ROAD & BRIDGE

A motion was made by Daily, seconded by York and unanimously carried to execute the following agreement:

A G R E E M E N T

THIS AGREEMENT, made and entered into this date, by and between the Board of County Commissioners of the County of Carbon, a body politic and corporate, hereinafter referred to as "County"; MOBILE PREMIX COMPANY, party of the second part, hereinafter referred to as "Mobile Premix"; and LOREN MILLER, party of the third part, hereinafter referred to as "Miller",

W I T N E S S E T H :

WHEREAS, Mobile Premix Company owns certain road base gravel subject to Miller's right of royalty, which the County wishes to buy, and

WHEREAS, the parties hereto wish to put in writing their agreement as to the purchase of such road base gravel by the County;

NOW, THEREFORE, in consideration of the premises, and the mutual covenants and agreements set forth herein, IT IS AGREED AS FOLLOWS:

1. The County hereby agrees to purchase 16,600 tons of 3/4-inch road base gravel and 9,400 tons of 1 1/2-inch road base gravel from Mobile Premix and to pay Mobile Premix \$1.75 per ton for such road base gravel and to directly pay to Loren Miller his royalty in such gravel in the amount of 50¢ per ton. Mobile Premix agrees to sell the County such road base gravel for said amount, and Loren Miller agrees to relinquish any claims he has to such gravel for the 50¢ a ton royalty to be paid directly by the County to him. All parties further agree that there is in fact the quantity of gravel sold as set forth herein.

2. Mobile Premix specifically warrants to the County that no other person or entity other than Mobile Premix Company and Loren Miller have any claim to such road base gravel.

May 6, 1986

3. Loren Miller further agrees to give the County until October 1, 1986 to remove the gravel from his premises.

4. Payment shall be made within twenty (20) days after execution of this contract by all parties.

SALARY RESOLUTION

A motion was made by York, seconded by Daily and unanimously carried to execute the following resolution:

R E S O L U T I O N N O . 1 9 8 6 - 1

WHEREAS, the Board of County Commissioners of Carbon County, Wyoming are lawfully assembled in regular meeting of said Board in the Courthouse Building, Rawlins, Wyoming, and

WHEREAS, Section 18-3-107, Wyoming Statutes 1977 as amended, provided that the Board of County Commissioners of each County in the State of Wyoming shall meet not later than June first of the year preceding an election for County Assessor, County Prosecuting Attorney, County Clerk, Clerk of the District Court, County Sheriff, and County Treasurer for the purpose of setting salaries for such officials, and

WHEREAS, Section 18-3-107, Wyoming Statutes 1977 as amended, also provides that each County Commissioner will be paid such compensation as the Board of County Commissioners determine by resolution, and

WHEREAS, the Board of County Commissioners has duly deliberated and discussed the various factors which are determinative of said salaries, and

WHEREAS, the Board has determined that the County Assessor, County Clerk, Clerk of the District Court, and County Treasurer shall be paid an annual salary for the calendar years 1987 through 1990 in the amount of \$36,000.00, together with the same benefits as accorded other County employees, and

WHEREAS, the Board has determined that the County and Prosecuting Attorney and County Sheriff shall receive an annual salary, including in the case of the Sheriff any housing allowance, in the amount of \$38,000.00 for the calendar years 1987 through 1990, together with the same benefits as other County employees receive, and

WHEREAS, the Board of County Commissioners has further determined that each County Commissioner shall be paid an annual salary in an amount of \$7,200.00 for the calendar years 1987 through 1990, and

WHEREAS, Board of County Commissioners has determined that it is appropriate for the Clerk of the District Court to continue to deposit funds received by said office from the State Workmen's Compensation Fund received for services rendered to said Fund which are a part of the duties of said office and for which County salaries are paid into the general fund of Carbon County, Wyoming;

NOW, THEREFORE, BE IT RESOLVED that the County Assessor, County Clerk, Clerk of the District Court, and County Treasurer of Carbon County, Wyoming, shall receive an annual salary of \$36,000.00 for the calendar years 1987 through 1990. In addition to said monetary compensation, the said elected officers of Carbon County, Wyoming shall receive the same benefits as accorded other employees of Carbon County, Wyoming at the date of the adoption of this resolution, including but not limited to the same retirement-matching contributions from the County as other County employees, and the same coverage under any County insurance policies at the rates accorded other County employees.

BE IT FURTHER RESOLVED that the County and Prosecuting Attorney and the County Sheriff of Carbon County, Wyoming shall receive an annual salary of \$38,000.00 for the calendar years 1987 through 1990. In addition to said monetary compensation, the said elected officers of Carbon County, Wyoming shall receive the same benefits as accorded other employees of Carbon County, Wyoming at the date of the adoption of this Resolution, including but not limited to the same retirement-matching contributions from the County as other County employees, and the same coverage under any County insurance policies at the rates accorded other County employees. The annual compensation provided herein for the Sheriff shall be deemed to include any housing allowance to which the Sheriff is entitled.

BE IT FURTHER RESOLVED that each of the County Commissioners with an effective term commencing January 1, 1987, and thereafter until changed, shall be compensated in the amount of \$7,200.00 annually. In addition to said monetary compensation, the said County Commissioners shall receive the same benefits as accorded other employees of Carbon County, Wyoming at the date of the adoption of this Resolution, including but not limited to the same retirement-matching contributions from the County as other County employees, and the same coverage under any County insurance policies at the rates accorded other County employees.

BE IT FURTHER RESOLVED that the Coroner of Carbon County receive an annual salary of \$7,200.00 for the calendar years 1987 through 1990. In addition to said monetary compensation, the Coroner of Carbon County, Wyoming shall receive the same benefits as accorded other employees of Carbon County, Wyoming at the date of the adoption of this resolution, including but not limited to the same retirement-matching contributions from the County as other County employees, and the same coverage under any County insurance policies at the rates accorded other County employees. The salary

specified herein for the Coroner shall be in lieu of any statutory fees or remuneration.

BE IT FURTHER RESOLVED that the Clerk of the District Court, Carbon County, Wyoming deposit any funds received by that officer from the State of Wyoming for services rendered to the Worker's Compensation Fund to the general fund of Carbon County, Wyoming.

BE IT FURTHER RESOLVED that the salaries herein established shall not be changed during the four-year term of said elective officers.

BE IT FURTHER RESOLVED that any and all prior Resolutions in conflict herewith are hereby repealed.
