CAMPAIGN REPORTING REQUIREMENTS, 22-25-106 (a), W. S. 1977 - All candidates whether successful or not, shall file under oath a fully itemized statement of receipts and expenditures by August 29, 1986.

FILING OFFICES, 22-25-107 - Any candidate for municipal, county, judicial, school or college board office and any political action committee or candidate's campaign committee shall file with the county clerk. Any candidate for a state legislative or district judgeship office and any political action committee or candidate's campaign committee shall file with the secretary of state and county clerk. Any candidate for statewide office shall file with the secretary of state.

A candidate who fails to file, within the time required, a full and complete itemized statement of receipts and expenditures is guilty of a misdemeanor, and shall not receive a certificate of nomination, or election, nor shall he enter upon the duties of the office, as the case may be, and a vacancy exists. 22-25-108, W. S. 1977

you may be given assistance by a person of your choice. Also, if you have questions regarding the accessibility of your polling place, please contact the County Clerk.

D I S A S T E R D E C L A R A T I O N

WHEREAS, Carbon County, suffered damage to roads, bridges, culverts, farmlands, homes, business, and other public facilities caused by flood occurring in June 9, 1986.

WHEREAS, the cost of cleanup, repair and replacement of such facilities damaged is far in excess of Carbon County resources available.

NOW, THEREFORE, BE IT RESOLVED that the Board of Carbon County Commissioners for Carbon County, for the Eastern half of Carbon County, Wyoming, declare this to be a disaster area.

CARBON COUNTY MEMORIAL HOSPITAL BOARD

A motion was made by York, seconded by Grieve and unanimously carried to reappoint Gloria Rasberry to the Carbon County Memorial Hospital Board for a five year term beginning July 1, 1986 and ending July 1, 1991.

CARBON COUNTY MUSEUM BOARD

A motion was made by York, seconded by Grieve, and unanimously carried to reappoint Edward M. Tierney to the Carbon County Museum Board for a three year term beginning July 1, 1986 and ending July 1, 1989.

A motion was made by York, seconded by Grieve, and unanimously carried to reappoint George Brox to the Carbon County Museum Board for a three year term beginning July 1, 1986 and ending July 1, 1989.

EMERGENCY HEALTH CARE PROGRAM

A public hearing was held on the proposed use of Community Services Block Grant Funds for Emergency Health Care in Carbon County from October 1, 1986 through September 30, 1987. Carbon County Community Resources Center requested the funding of \$23,620.00 for the 1986-1987 budget year. There being no other applicants for the funds, a motion was made by York, seconded by Grieve and unanimously carried to award the grant and execute a letter of application to the State Division of Community Programs for the Carbon County Community Resource Center.

CARBON COUNTY LODGERS TAX ASSESSMENT PROMOTION COMMITTEE

Ken Keldsen, Chairman of Carbon County Lodgers Tax Assessment Promotion Committee discussed his organization's progress and future plans aimed toward the adoption of a 2% countywide lodging tax. The lodging tax is to be used for the promotion of tourism in Carbon County.

CARBON COUNTY ROAD AND BRIDGE

Frank Smith, Road and Bridge Supervisor reported to the Commissioners on the recent flood damage and repairs.

The Commissioners allowed \$18,000.00 for the purchase of a used roller.




