MEMORIAL HOSPITAL ADDITION

A motion was made by Daily, seconded by Graalman and unanimously carried to execute a permanent easement to David L. and Frances F. Maler concerning the following real estate situated in Carbon County, State of Wyoming:

A 30 ft. strip of land in Tract 1 & 2 of the Memorial Hospital Addition to the City of Rawlins, Wyoming, 15 ft. on either side of the following described centerline;

Beginning at a point which bears S24°21'W, 16.33 ft. from the Southwest corner of the Morgan Manor Tract;

Thence S88°55'E, 150.0 ft. to a point;

Thence S79°00'E, 55.0 ft. to a point;

Thence S65°00'E, 50.0 ft. to a point;

Thence S51°00'E, 73.0 ft. to a point;

Thence S76°00'E, 77.49 ft. more or less, to a point on the West line of Sixteenth Street, the point of termination, said 30 ft. wide strip of land being 405.49 ft. in length and said side lines of said strip of land intended to lengthen or shorten to meet existing property lines, said strip containing .279 acres, more or less.

A copy of the easement is on file in the office of the County Clerk.

CARBON COUNTY SENIOR SERVICES

A motion was made by Daily, seconded by Graalman and unanimously carried to execute a lease agreement by and between the Board of County Commissioners of Carbon County and the Carbon County Senior Services Inc. covering the Senior Centers in Rawlins, Baggs, Dixon, Encampment, Medicine Bow and Saratoga. The lease agreement is on file in the office of the County Clerk.

CARBON COUNTY PUBLIC HEALTH

A public hearing was conducted for the proposed use of Community Services Block Grant Funds.

A motion was made by Graalman and seconded by Daily and unanimously carried to allow Sherrie Patch, Public Health nurse to apply for the Community Services Block Grant of \$20,830 to fund the Emergency Health Care Program.

CARBON COUNTY MUSEUM BOARD

A motion was made by Graalman, seconded by Daily and unanimously carried to reappoint Charlotte Vivion to the Carbon County Museum Board for a three year term beginning July 1, 1987 and ending July 1, 1990.

CARBON COUNTY MEMORIAL HOSPITAL BOARD

A motion was made by Daily, seconded by Graalman and unanimously carried to reappoint William J. Vasey to the Carbon County Memorial Hospital Board for a five year term beginning July 1, 1987 and ending July 1, 1992.

CARBON COUNTY PUBLIC LIBRARY

Nominations were opened for a Carbon County Public Library Board Member. Jake Fleming was nominated by Daily. Caroline Hatton was nominated by Graalman. A motion was made by Graalman that nominations cease. Roll was called with the following results: York, Fleming; Daily, Fleming; Graalman, Hatton. Jake Fleming was appointed to the Carbon County Public Library Board for a three year term beginning July 1, 1987 and ending July 1, 1990.

CARBON COUNTY BUDGET FOR FISCAL YEAR 1987-88

The Commissioner reviewed the department budgets and made numerous reductions in line items. They also explained to Don Besler, Rawlins Parks and Recreation Director, Della Vivion, Mayor and Carlos Miranda, City Manager why the County must withhold funds committed at the Recreation Center until the City of Rawlins has their funds in place for the project. Hanna Recreation Center requested funds for their budget.

THERE BEING NO FUTHER BUSINESS, the meeting was adjourned.
