REGULAR MEETING

July 7, 1987

The Board met at 10:00 a.m. Commissioners James A. York, O. R. "Bud" Daily and Gary Graalman were present. James A. York, Chairman.

MINUTES of the regular meeting of June 16, 1987 were read and approved.

REPORTS of the County Officers were audited and placed on file.

RAWLINS-CARBON COUNTY AIRPORT BOARD

The Commissioners accepted the resignation of Gregg Olson from the Rawlins-Carbon County Airport Board.

A motion was made by Graalman, seconded by Daily and unanimously carried to appoint Keith Lambertson to fill the unexpired term of Gregg Olson beginning July 7, 1987 and ending February 1, 1992.

CARBON COUNTY LIQUOR LICENSES

A motion was made by Daily, seconded by Graalman and unanimously carried to lower retail liquor and malt beverage license fees for fiscal year 1987-88 as follows:

Retail Liquor License from \$1,500.00 to \$1,000.00
Retail Malt Beverage License from \$500.00 to \$300.00

The limited retail liquor license fee will remain the same \$1,000.00.

CARBON COUNTY FIRE DEPARTMENT

Frank Erickson, County volunteer fireman from Muddy Gap presented the Commissioners with two proposals of used fire trucks to be used in the Muddy Gap area.

A motion was made by Daily, seconded by Graalman and unanimously carried to purchase a used fire truck from Becker Fire Equipment Co. for \$10,000.00.

CARBON COUNTY ROAD AND BRIDGE DEPARTMENT

Frank Smith, supervisor gave his report to the board.

The following bids were received for 50,000 tons of crushed aggregate:

JUVENILE COMMUNITY ALTERNATIVES

A contract was executed between the Wyoming Division of Public Assistance and Social Services and the Carbon County Commissioners concerning juvenile community alternative services in Carbon County and disbursement of funds up to \$19,318.00 for the period of July 1, 1987 to June 30, 1988.

CARBON COUNTY TREASURER

Leonard Page, auditor, Dick Engstrom, Carbon County Treasurer and Cindy Baldwin, First Deputy Treasurer appeared before the Commissioners to request a special account be established for tax protest monies.

A motion was made by Daily, seconded by Graalman and unanimously carried to approve establishment of an escrow account to accomodate tax protest funds.

Also considered was the need for a bad check account.

A motion was made by Daily, seconded by Graalman and passed to set up a bad check account in the Treasurer's office with a beginning balance of \$2,000.00.

DATA PROCESSING

Leonard Page, auditor and Marilyn Bradford, Carbon County Data Processing manager discussed the need of clarifying the encumbrance system for Carbon County Government.

The Commissioners approved a notice stating purchase order procedure.

The Data Processing department was given authorization to administer all aspects of Section 125 of the Internal Revenue Service code and to sign all necessary forms concerning Section 125 for Carbon County Government.


BUDGET HEARING
