A motion was made by Graalman, seconded by Daily and unanimously carried to reappoint Phil Weber to the Baggs Solid Waste Board for a three year term beginning September 2, 1987 and ending September 2, 1990.


CARBON COUNTY CLERK OF THE DISTRICT COURT
