CARBON COUNTY 2% LODGING TAX

A motion was made by Daily and seconded by Graalman to approve the first reading of the Lodging Tax Ordinance as follows:

L O D G I N G T A X O R D I N A N C E

AN ORDINANCE IMPOSING AN EXCISE TAX UPON
SALES OF LODGING SERVICES AS SET FORTH IN
WYO. STAT. § 39-6-412(b)(11) (1977, AS
AMENDED), FOR THE PRIMARY PURPOSE OF PROMO-
TION OF LOCAL TRAVEL AND TOURISM.

BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF
THE COUNTY OF CARBON, STATE OF WYOMING.

Section 1. This ordinance shall be known, and may be
cited, as the Carbon County Lodging Tax Ordinance.

Section 2. From and after the effective date of this
ordinance, within the limitation herein set out, there is hereby
imposed and there shall be collected and paid an excise tax upon
every sales of lodging services; as provided for in Wyo. Stat.
§ 39-6-412(b)(11) (1977, as amended) and defined in Wyo. Stat.
§ 39-6402(a)(xi) (1977, as amended), made within the County of
Carbon, State of Wyoming, at a rate of 2% of the sale price paid
therefor.

Section 3. Insofar as they relate to sales taxes, Wyo.
Stat. § 39-6-401 through § 39-6-417 (1977, as amended), and Wyo.
Stat. § 39-5-101 (1977, as amended), are incorporated herein by
reference, and made a part hereof, except that the County of
Carbon, State of Wyoming shall be substituted for the State of
Wyoming as the taxing agency, and an additional license shall not
be required if one has been or is issued to the vendor under Wyo.
Stat. § 39-6-403 (1977, as amended).

Section 4. All amendments, subsequent to the effective
date hereof, of the sections herein set forth in Section 3 re-
lating to sales tax and not in conflict with this section or Wyo.
Stat. § 39-6-518 (1977) shall automatically become a part of the
Carbon County Lodging Tax Ordinance.

Section 5. The County of Carbon shall contract prior
to the effective date of the Carbon County Lodging Tax Ordinance
with the State Tax Commission to perform all functions incident
to the administration or operation of the Carbon County Lodging
Tax Ordinance.

Section 6. The amount subject to the tax imposed here-
in shall not include the amount of any sales tax or use tax
imposed by the State of Wyoming.


CARBON COUNTY ROAD & BRIDGE
