A zone change from RAM (Ranching, Agriculture, Mining) to RD-25 (Residential Development - 25 acrea) to allow for development of a single family residence on 25 acres of land legally described as in the NE<sup>1</sup>SW<sup>1</sup> of Section 13, Township 21 North, Range 88 West, Carbon County, Wyoming.
