OLD PENITENTIARY JOINT POWERS BOARD

A motion was made by Graalman, seconded by Daily and unanimously carried to reappoint Darlene O'Melia to a three year term beginning May 3, 1987 and ending May 3, 1990.

CARBON COUNTY AGENT

A motion was made by Daily, seconded by Graalman and unanimously carried to execute an agreement between the Board of County Commissioners and the University of Wyoming to employ a University Extension summer intern agent in agriculture, home economics, 4-H and community development.

CARBON COUNTY FIRE DEPARTMENT

A motion was made by Daily, seconded by Graalman and unanimously carried to execute the 1987 Wildland Fire Control Annual Plan. The plan is an cooperative agreement between Carbon County, the Wyoming State Forestry Division, the U.S.D.A. Forest Service, and the U.S.D.I. Bureau of Land Management. A copy of the agreement is on file in the office of the County Clerk.

CARBON COUNTY PLANNING & DEVELOPMENT

A motion was made by Daily and seconded by Graalman to approve Case File No. 87-04.

Case File No. 87-04 - Zone Change - Ryan Park Land Co., 228 Corthell Road, Laramie, WY 82070. A zone change from RAM (Ranching, Agricultural, Mining) to RB (Retail Business) to bring two existing parcels (store parcel - 1 acre; school parcel - .39 acres), previously used for business, into conformance with current zoning regulations on 1.39 acres legally described as in the S $\frac{1}{2}$ N $\frac{1}{2}$ SW $\frac{1}{4}$ of Section 28, Township 16 North, Range 81 West, Carbon County, Wyoming.

A RESOLUTION SUPPORTING SUBMITTAL OF AN APPLICATION FOR CONSTRUCTION OF A SUPERCONDUCTING SUPER COLLIDER IN THE RED DESERT OF THE STATE OF WYOMING.

WHEREAS, the Carbon County Board of Commissioners have actively and seriously supported economic development within Carbon County; and

WHEREAS, the Board recognizes that efforts from the State of Wyoming in the field of economic development benefits all political jurisdictions and the State in general; and

WHEREAS, the federal government is soliciting site proposals from interested states for the construction of a Superconducting Super Collider testing facility; and

WHEREAS, the Red Desert offers an ideal site for the fifty-two (52) mile testing tunnel which is required for the Superconducting Super Collider; and

WHEREAS, helium is an essential resource to testing involved with the Superconducting Super Collider and the State of Wyoming is one of two locations in the United States which produces helium.

NO THEREFORE, be is resolved that the Board of Commissioners of the County of Carbon, Wyoming approves and supports the submission of an application, sponsored by the State of Wyoming for the construction of the Superconducting Super Collider in the Red Desert of our State.


