FOREST HIGHWAY 11 (FH 11)

A hearing was held concerning the re-construction of Forest Highway 11 (Battle Lake Road) by the Medicine Bow National Forest and the Wyoming Highway Department. Comments were received expressing the opinion that a gravel alternative be considered. The gravel alternative does not meet standards required for a State Secondary Highway System road. The County would have to agree to place a graveled road on their system and the Commissioners, by letter to the Federal Highway Administration, stated that the County cannot add the road, paved or unpaved to the County Road System as costs for right-of-way acquisition and maintenance of the highway would be prohibitive.

COUNTY INSURANCE

Bill Anthony met with the Commissioners to ask permission to review the County insurance policies.

CARBON COUNTY FIRE DEPARTMENT

A motion was made by Daily, seconded by Graalman and unanimously carried to execute an Emergency Fire Suppression Account Agreement by and between Carbon County and the State of Wyoming Forestry Division. The agreement is on file in the office of the County Clerk.

JEFFREY CENTER BOARD

The Commissioners accepted with regret, the resignation of Fred Roberts from the Jeffrey Center Board.

A motion was made by Graalman and seconded by Daily to appoint David Rader to the unexpired term of Fred Roberts beginning May 19, 1987 and ending December 4, 1987.

FIREWORKS

A request was made for \$500.00 from the County towards a fireworks display.

A motion was made by Daily and seconded by Graalman to allow the \$500.00. After discussion of the question, roll was called with the following results: Daily, aye; York, nay; Graalman, nay.

A motion was made by Graalman and seconded by Daily to allow the Carbon County Fire Department to supervise a fire works display on County property subject to legal approval. The motion carried.

CARBON COUNTY ECONOMIC DEVELOPMENT

A motion was made by Daily, seconded by Graalman and unanimously carried to pass the following:

RESOLUTION NO. 1987-8

RESOLUTION AUTHORIZING THE SUBMISSION OF A GRANT APPLICATION BY CARBON COUNTY FOR PLANNING-ONLY FUNDS FOR DAVID Q. TOGNONI FROM THE COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM AND CERTIFYING THAT ALL PUBLIC PARTICIPATION REQUIREMENTS HAVE BEEN MET

WHEREAS, the Carbon County Board of Commissioners has strongly and seriously supported economic development for Carbon County; and

WHEREAS, Carbon County has suffered an extreme downturn in its mineral industry since 1982; and

WHEREAS, Carbon County is blessed with a wealth of various mineral resources; and

WHEREAS, David Q. Tognoni desires to research available records to perform minerals research for economic development in Carbon County; and

WHEREAS, this proposed research offers great opportunity to alert the minerals industry to economic resources in Carbon County; and

WHEREAS, CDBG funds are available to conduct feasibility studies for industrial development which will stimulate and enhance economic development in the State of Wyoming.

NOW, THEREFORE, BE IT RESOLVED that the Carbon County Board of Commissioners approves the submission of this grant application to the State of Wyoming and further certifies that all public participation requirements have been met.

PASSES, APPROVED AND ADOPTED this 19th day of May, 1987.





CARBON COUNTY

BOARD OF EQUALIZATION

The Carbon County Board of Equalization met Tuesday, May 26th, 1987 at 10:00 a.m. Members present: Commissioners, Bud Daily and Gary Graalman; Assessor, Darrell Stubbs. Commissioner James A. York, absent.

Taxpayers appearing before the Board were: Bill Cooper, Joe Turner and Mike Tysor asking about the assessment on the four-plex units in the Heart "B" Subdivision in Medicine Bow, Wyoming.

They were under the impression the units were assessed on the mortgage of \$186,000.00. Mr. Stubbs informed them that they were not, and are assessed by the State Board of Equalization guidelines for 1987 of 25% of 1967 Wyoming Manual replacement cost.


The gentlemen thanked the Board for their time and hoped the statewide reappraisal would be completed by 1988 and the respective values would show the market value.

Next to appear was Mr. Robert Grieve, representing the Baggs Investment Group. He requested that functional obsolescence be considered on the Valley State Bank building in Baggs, Wyoming.

Mr. Grieve pointed out that the Bank is closed and the building will never be used for that purpose again and requested functional obsolescence be taken into consideration pertaining to the extra concrete and construction necessary for the vault and banking facilities.

The Board took the request under advisement.

The meeting adjourned as no other taxpayers appeared and will reconvene June 8th if other appeals are filed for their consideration.
