SENIOR SERVICES

SENIOR SERVICES BOARD

A motion was made by Graalman, seconded by Daily and unanimously carried to appoint Dorothy Laubach to the unexpired term of Clarence Mundschenk beginning December 2, 1987 and ending March 4, 1989.

CARBON COUNTY LIBRARY

Bess Sheller, Carbon County Library Director discussed construction progress on the new Encampment Library.

EXTENSION SERVICES

Marilyn Toellner, Extension Agent and Jim Nix, Agriculture Agent voiced their concerns on the proposed changes by the University of Wyoming in the extension services program. The Commissioners asked the agents to arrange a meeting with all parties concerned to discuss the reorganization.

ROAD AND BRIDGE

Frank Smith, Carbon County Road & Bridge Supervisor reported on snow removal throughout the county.

A motion was made by Daily, seconded by Graalman and unanimously carried to allow the purchase of a pager system for \$699.00.

A motion was made by Daily, seconded by Graalman and passed to send three Road & Bridge employees to an explosives school in Pryce, Utah for five days. Total costs, including travel, board, room and tuition will not exceed \$1,000.00.
