The Commissioners accepted with regret the resignation of Delores R. Loudon from the Jeffrey Center Board.

A motion was made by Graalman, seconded by Daily and unanimously carried to appoint Roger Vagner to the unexpired term of Delores R. Loudon beginning May 17, 1988 and ending December 4, 1991.

NORTHWEST COMMUNITY ACTION PROGRAMS OF WYOMING, INC.

The Commissioners suggested that the representatives of N.O.W.C.A.P. pursue funding from Community Service Block Grant funds for weatherization, if any are available other than the funds for the Emergency Medical Program.


CARBON COUNTY ROAD & BRIDGE


HEALTH INSURANCE
