June 7, 1988

CARBON COUNTY MEMORIAL HOSPITAL BOARD

A motion was made by Daily, seconded by Graalman and unanimously carried to reappoint Roger J. Schneider to a five year term on the Carbon County Memorial Hospital Board beginning July 1, 1988 and ending July 1, 1993.

CARBON COUNTY MUSEUM BOARD

A motion was made by Daily, seconded by Graalman and unanimously carried to reappoint Jean Lambertson and Ronald Wolfard to three year terms on the Carbon County Museum Board beginning July 1, 1988 and ending July 1, 1991.

CARBON COUNTY PUBLIC LIBRARY

A motion was made by Graalman, seconded by Daily and unanimously carried to reappoint Virginia Briggs and Candace France to three year terms beginning July 1, 1988 and ending July 1, 1991; contingent on the County Attorney's opinion concerning serving two full terms.

CARBON COUNTY SHERIFF

A motion was made by Daily, seconded by Graalman and unanimously carried to execute an agreement by and between Donald F. Sherrod, Sheriff of Carbon County and the City of Rawlins to appoint as many of the City's Police Officers as Special Deputy Sheriffs as he desires subject to the approval by the County Commissioners. The agreement is on file in the office of the County Clerk.

THERE BEING NO FURTHER BUSINESS, the meeting was adjourned until the following day.

TRANSFER OF MALT BEVERAGE PERMIT

A hearing was held at 10:00 a.m. June 8th, 1988 in the office of the County Commissioners to transfer a malt beverage permit from Patsy A. Payne a/b/a/ The Place to Douglas G. Frederick and Diana G. Frederick d/b/a The Place. There being no protests, a motion was made by Daily, seconded by Graalman and unanimously carried to allow the transfer.

HANNA MEDICAL SERVICES

A motion was made by Graalman, seconded by Daily and unanimously carried to execute an agreement by and between Carbon County and Alla Reddy, M.D. to provide medical services and provide a clinic in Hanna for \$1,250.00 per month. The agreement is on file in the office of the County Clerk.

CARBON COUNTY HEALTH NURSE

A motion was made by Daily, seconded by Graalman and unanimously carried to apply for a Community Service Block Grant of \$23,261.00 from the Wyoming Division of Community Programs. The grant will be used for an Emergency Health Care Program.

A motion was made by Daily, seconded by Graalman and unanimously carried to execute a contract between Carbon County, Wyoming State Division of Health and Medical Services, Carbon County Public Health Nursing Services and Northwest Colorado Visiting Nurse Association to provide public health and home health nursing services for an area in Wyoming surrounding and including the communities of Baggs, Dixon and Savery. The contract is on file in the office of the County Clerk.

WATER COMMISSIONER

A motion was made by Daily, seconded by Graalman and unanimously carried to execute a Memorandum of Agreement between the Wyoming State Engineer's Office, Carbon County and the City of Cheyenne to provide a Deputy Water Commissioner. Memorandum is on file in the office of the County Clerk.

Susan Grafton appeared before the Commissioners to review the planning budget.




