The Board signed a letter of support for the grant application.

PUBLIC HEALTH

A purchase contract for speech therapy service was executed. The contract is between Carbon County Public Health Nursing Service and Karen Thornton, provider. A copy of the contract is on file in the office of the County Clerk.

LIBRARY BOARD

A motion was made by Graalman, seconed by Wille and passed to appoint Leonard Clark to a three year term on the Carbon County Library Board beginning July 1, 1989 and ending July 1, 1992.
