## REGULAR MEETING

July 5, 1989

MINUTES of the regular meeting of June 20, 1989 were read and approved.

FINANCIAL REPORTS of the County Officers were audited and placed on file.

## TREASURER

Dick Engstrom, County Treasurer requested approximately \$21,054.00 for the installation of computer equipment in the motor vehicle department. A motion was made by Graalman, seconded by Wille and passed to allow the expenditure and the hiring of Woodward Electric to do the electric work.

## CARBON BUILDING

Bud Greene, Building & Grounds supervisor reported on the rebid of the Carbon Building roof resurface.

## ASSESSOR

Darrell Stubbs, County Assessor announced the assessed valuation for Carbon County, fiscal year 1989-1990 at \$296,304,950.00.

## SHERIFF

Don Sherrod, County Sheriff discussed filling vacancies in the jail and a paper server.

## WATER COMMISSIONER

A motion was made by Wille, seconded by Graalman and carried to enter into an agreement with the State Engineer's office and the City of Cheyenne concerning water commissioner services in the Little Snake River, Encampment River and Douglas Creek, Water Division No. I of the State of Wyoming. A copy of the agreement is on file in the office of the County Clerk.

## ROAD &amp; BRIDGE

Don Neuman, Road & Bridge supervisor reported on damages to County Road 401 due to the construction of the Sage Creek Transmission Pipeline for the City of Rawlins.

## SINCLAIR LANDFILL

A motion was made by Graalman, seconded by Wille and passed to approve the following:

R E S O L U T I O N     1 9 8 9 - 4

TO: The United State Environmental Protection Agency

RE: The Sinclair Landfill

The Wyoming Carbon County Commissioners submit the following resolution to the United State Environmental Protection Agency (EPA) regarding the hazardous waste landfill cover at the Sinclair refinery;

WHEREAS, Carbon County Commissioners expressed to the EPA in 1988 their confidence in the safety of the landfill;

WHEREAS, in compliance with Federal regulations, the Sinclair refinery closed its hazardous waste landfill in November, 1988;

WHEREAS, the refinery is actively engaged in obtaining an approved permanent cap for the landfill;

WHEREAS, environmental technology in this areas is still developing;

WHEREAS, the landfill cover design as recommended by Golder Associates for Sinclair has been successfully used on other areas;

WHEREAS, the Sinclair landfill is located in an arid climate ideally suited for a long-term natural landfill cover using several feet of native soils, clay and gravel as a cap;

WHEREAS, the Sinclair refinery is an important economic asset

to the citizens of Carbon County and we support prudent measures which help preserve the competitiveness of the refinery in inter-state markets.

THEREFORE, BE IT RESOLVED that the Carbon County Commissioners strongly believe in the integrity of the landfill cover as recommended to Sinclair by Golder Associates and we urge the EPA to accept this proposed design.
