LIQUOR LICENSE MORATORIUM

DESIGNATION OF DEPOSITORYES

A motion was made by Wille, seconded by Graalman and passed to designate all federal and state chartered banks and savings and loans in Carbon County with F.D.I.C. and F.S.L.I.C. approval as County depositories.

JEFFREY CENTER BOARD

A motion was made by Wille, seconded by Graalman and carried to appoint Bill Harshman to a five year term on the Jeffrey Center Board beginning December 4, 1989 and ending December 4, 1994.

MUSEUM BOARD

A motion was made by Graalman, seconded by Wille and carried to appoint Edward M. Tierney and George Brox to five year terms on the Carbon County Museum Board beginning July 1, 1989 and ending July 1, 1994.

ROAD & BRIDGE

The Board entered into a seven year lease with Wyoming Machinery of Casper for a new Caterpillar 140G Motor Grader.

THERE BEING NO FURTHER BUSINESS, the meeting was adjourned.
