CARBON COUNTY SCHOOL DISTRICT #1 RECREATION BOARD

A motion was made by Wille, seconded by Graalman and carried to appoint Gary Graalman to the Carbon County School District #1 Recreation Board as an exofficio member.

BAGGS SOLID WASTE DISPOSAL BOARD

A motion was made by Wille, seconded by Graalman and carried to appoint Thomas W. Shepard to a three year term beginning September 4, 1988 and ending September 4, 1991.

CARBON COUNTY FAIR BOARD

A motion was made by Wille, seconded by Graalman and carried to appoint Leo Chapman to a five year term on the Carbon County Fair Board beginning February 1, 1989 and ending February 1, 1994.

WYOMING STATE HIGHWAY DEPARTMENT

Jim Kladianos and Joe Yovich, representing the Wyoming State Highway Department reported on the Farm to Market road program.

COUNTY CORONER

Carbon County Coroner, Zach Rinderer met with the Commissioners to discuss the Coroner operation center.

CARBON COUNTY SCHOOL DISTRICT ONE

A motion was made by Wille, seconded by Graalman and carried to allow the pay back plan presented by Superintendent, Mary Gibson. The plan calls for billing twice a year by the County for the current six month utility bill due and 1/24th of the past due amount.

COUNTY SHERIFF

County Sheriff, Don Sherrod presented budget figures showing a shortfall in the Jail meal allowance fund.

CARBON COUNTY PLANNING

A motion was made by Graalman and seconded by Wille to approve Case File No. 88-15.

Case File No. 88-15 - Amendment - Carbon County Planning Commission, Carbon Building, Suite 320, Rawlins, WY 82301. To amend the 1972 Carbon County Zoning Resolution, specifically to add highway construction camps, gravel mines, processing plants and other related highway construction activity as a Permitted Use in the RAM (Ranching, Agriculture, Mining) District; to add non-highway construction camps and other related activity and facilities as a Special Use Permit under the RAM Zoning District; to delete all of Section 465; and, add to Section 600 the definitions for "Highway Construction, Camps and Related Facilities", "Gravel Mines", "Gravel Mining" and "Processing Plants".

Roll was called with the following results: Daily, aye; Graalman, aye; Wille, aye.

Susan Grafton, Carbon County Planner presented her Administrator's Report to the Board for the month of January 1989.

A motion was made by Wille, seconded by Graalman and passed to appoint Irene E. Archibald to a three year term on the Carbon County Planning & Development Board beginning February 7, 1989 and ending December 4, 1991.

CARBON COUNTY ECONOMIC DEVELOPMENT

Sherrod France, E.D.C. representative updated the Board on the progress of the Green Mountain Ski project.

Susan Grafton reported on the funding under the State grant for Timeline, Inc.

Frank Smith, County road supervisor gave his report to the Board for January, 1989.


CARBON COUNTY JOINT TOURISM POWERS BOARD
