RAWLINS SOCCER ASSOCIATION

Zack Rinderer, representing the Rawlins Soccer Association presented a plan to use the County owned land east of Harshman Street to develop soccer fields and parks. The County Fair Board passed a resolution calling for a study and soil testing of the area in question at their regular meeting March 7, 1989.

The Commissioners are not opposed to the proposed plan as long as it will not cost the County money.

A motion was made by Wille, seconded by Graalman and passed to support the Fair Board's resolution.

JUVENILE COMMUNITY ALTERNATIVE PROGRAM

Marianne Lee, Rawlins Field Office Manager for D-PASS reported on the new rules for the Juvenile Community Alternative program offered by the Wyoming Department of Health and Social Services.

Ms. Lee will rewrite Carbon County's plan and meet with the Commissioners on May 2, 1989 at 2:30 P.M. An application and public hearing will also be held at the May 2nd meeting concerning the Juvenile Community Alternative funding.

ROAD & BRIDGE

Representatives from the Road & Bridge Department gave reports on various areas.

Office Manager, Patricia Schuler is working on work hour policy for the department.

Construction Supervisor, Don Neuman reported on gravel hauling schedules, crew schedules and upcoming construction projects.

FIRE DEPARTMENT

A motion was made by Graalman, seconded by Wille and passed to appoint Danny Schinkel as the official Carbon County Fire Warden as authorized by State Statute, Senate Enrolled Act No. 14, dated February 2, 1989. The designation is effective June 8, 1989.

Danny Schinkel and members of the Sinclair Fire Department requested Sinclair's becoming a part of the Carbon County Fire Department network. To accomplish this a small tank truck and operating expenses similar to the other towns would be necessary. No action was taken at this time, but the group was asked to return in May for an answer.

COMMUNITY SERVICE BLOCK GRANT - DISCRETIONARY FUNDS

This funding is made available through the Community Services Block Grant discretionary component.
