Chairman Daily responded to the request by stating that County funding will be down for fiscal year 1990-91 and the Road & Bridge department has too many projects now that need to be completed before taking on new projects. Commissioners Wille was concerned about using Farm to Market monies. The Board requested more input from the public on the Rawlins Peak proposal.

#### CARBON COUNTY SOIL CONSERVATION DISTRICTS

Olin Sims, representing all three districts, announced their intention to petition the Board of County Commissioners requesting an election pursuant to Wyoming Statutes 11-16-134. The conservation districts are asking for a mill levy of one mill pursuant to Wyoming Statutes 11-16-133. They also would like to be on the next General Election ballot.

A motion was made by Wille, seconded by Graalman and carried to put the soil conservation districts on the general election ballot for a one mill tax levy. The districts involved are: Little Snake River, Medicine Bow and Saratoga-Encampment-Rawlins.

#### FIRE EXTINGUISHER BID

A bid opening was held at 1:30 for fire extinguisher service. Bids were submitted by Valley Fire Extinguisher Service and Rawlins Fire Extinguisher Service.

A motion was made by Wille, seconded by Graalman and carried to take the bids under advisement. County Building & Grounds manager, Bud Greene will review the bids.

#### SHERIFF

County Sheriff, Don Sherrod requested the hiring of two new people and raises for the present staff. The Board approved the hiring of two people and tabled the request for raises.

#### COMMUNITY SERVICES BLOCK GRANTS

The Commissioners signed two applications for Community Services Block Grant funds as presented by Becky Sintek. The applications were for Public Health and the C.R.C. group.

#### EXTENSION SERVICES

Becky Sintek requested approval of her expenses for travel and programs.

#### ROAD & BRIDGE

Don Neuman, County Road Supervisor, presented his monthly reports and updated the Board on current projects.

#### EASEMENT

A motion was made by Wille, seconded by Graalman and carried to execute a quit claim deed from Carbon County to John and Susan Lunt, and a right-of-way easement from John and Susan Lunt to Carbon County. The Board authorized Alan Mace to deliver the deed and receive the easement.

THERE BEING NO FURTHER BUSINESS, the meeting was adjourned.
