NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners that the county budget, as so revised and altered, be adopted as the official county budget for the 1990-91 fiscal year ending June 30, 1991.

CAMPAIGN REPORTING REQUIREMENTS, 22-25-106(a), W.S. 1977 - All candidates whether successful or not, shall file under oath, a fully itemized statement of receipts and expenditures by August 31, 1990.

Filing Office, 22-25-107 - Any candidate for municipal, county, judicial, school or college board office and any political action committee or candidate's campaign committee shall file with the county clerk. Any candidate for a state legislative or district judgeship office and any political action committee or candidate's campaign committee shall file with the secretary of state and county clerk. Any candidate for statewide office shall file with the secretary of state.

A candidate who fails to file, within the time required, a full and complete itemized statement of receipts and expenditures is guilty of a misdemeanor, and shall not receive a certificate of nomination, or election, nor shall he enter upon the duties of the office, as the case may be, and a vacancy exists. 22-25-108, W.S. 1977.

If you require assistance to vote by reason of blindness, disability, or inability to read or write, you may be given assistance by a person of your choice. Also, if you have questions regarding the accessibility of your polling place, please contact the county clerk.
