County Road & Bridge Supervisor, Don Neuman updated the Commissioners on the work Allen Mace is doing on all the county roads. Neuman also reported on County gravel pits and his local highway finance report dated 10/1/1990 to the U. S. Department of transportation.

EMERGENCY HEALTH GRANT

A motion was made by Wille, seconded by Graalman and carried to enter into an agreement with the State Department of Health, Division of Community Programs for an Emergency Health Grant. The grant for \$20,795.00 will be for the period of September 1, 1990 through August 31, 1991.

COURTHOUSE

A motion was made by Wille, seconded by Graalman and carried to accept the bid of Eric Smith to paint the halls of the Courthouse (\$3,600.00).
