Bromley also talked about a 1976 Chevrolet ambulance. The Commissioners said to sell the ambulance at the next Sheriff's sell, and to move the ambulance to the County yard.

MEMORIAL HOSPITAL BOARD

A motion was made by Graalman, seconded by Fleming and unanimously carried to appoint Judy Merrill to a five year term on the Memorial Hospital Board of Carbon County.

LIBRARY BOARD

A motion was made by Graalman, seconded by Fleming and unanimously carried to appoint Joan K. Evans and Adelaide Reinholtz to three year terms on the Carbon County Library Board.

ADULT HOME CARE

Kathy Matson and Scott Sessions met with the Commissioners to discuss Adult Home Care.

A motion was made by Fleming, seconded by Graalman and unanimously carried to participate in the Adult Home Care program administrated by the Carbon County Senior Services program. by matching up to 5% of the \$131,000.00 of state funding available.

CAPITAL FACILITIES TAX


Representatives from Kaiser and Company discussed fee and contract with Kaiser before the election. for the 1% capital facilities tax.
