PUBLIC HEARING

A public hearing was held concerning the transfer of County property to Park Manor Nursing and Convalescent Home. The property is described as follows:

A portion of Tract 2 of the Memorial Hospital Addition to the City of Rawlins, Carbon County, Wyoming more completely described as follows:

Beginning at the Southeast corner of that tract of land known as the Morgan Manors Tract, said point bearing SO 15'W, 845.66 ft. and N88 55'W, 25.0 ft. from the East $\frac{1}{4}$ corner of Section 18, T21N, R87W, 6th P.M., Carbon County, Wyoming, said point of beginning being on the West line of 16th Street;

Thence N88 55'W, 125.00 ft. along the South line of the said Morgan Manors tract to the West line of said Tract 2 of the Hospital Addition;

Thence SO 15'W, 31.45 ft. along the West line of said Tract 2 to a point on the Northerly line of a 30 ft. easement.

Thence S65 00'E, 0.81 ft. along said northerly line to a point;

Thence S51 00'E, 10.42 ft. along said northerly line to a point;

Thence S42 07'E, 3.67 ft. along said northerly line to the beginning of a curve to the left;

Thence along said northerly line and along said curve to the right, an arc distance of 112.29 ft., on a radius of 144.15 ft., through a central angle of 44 38', to a point;

Thence S86 45'E, 13.27 ft. along said northerly line to a point on the West line of 16th Street;

Thence N0 15'E, 87.87 ft. along the West line of 16th Street to the point of beginning, said parcel containing 0.204 acres, more or less.

County Civil Attorney, Wade Waldrip will write a letter of reply to NME Properties, Inc. correspondence of July 19, 1991.

A motion was made by Graalman, seconded by Fleming and unanimously carried to have Waldrip prepare a deed for the above described land.

ROAD & BRIDGE


