JOINT POWERS BOARD, HANNA-CARBON COUNTY

A motion was made by Fleming, seconded by Graalman and carried to appoint Rick Kinder to a three year term on the Joint Powers Board, Hanna-Carbon County, and appoint Ann R. Thresher to fill the unexpired term of Pamella S. Proffith on the Joint Powers Board, Hanna-Carbon County.

ECONOMIC DEVELOPMENT CORPORATION

Bob Dahl gave a report on current projects of the Carbon County Economic Development Corporation.

COMPUTER CONTRACT

Wade Waldrip, Deputy County Civil Attorney and Kermit Tipton, independent computer programmer met with the Commissioners to discuss a contract for computer services.

A motion was made by Fleming, seconded by Graalman and carried to enter into a contract with Tipton Computer Services for \$1800.00 per month, \$300.00 per month expenses and \$.23 per mile from Casper to Rawlins and back.

LITTLE SNAKE RIVER EVENTS CENTER BOARD

The Commissioners signed a letter addressed to the Little Snake River Events Center Board directing only equestrian events be held in the event center until the building is brought into compliance with state rules, regulations and codes pursuant to the General Plan Correction List from the State Fire Marshal.

PUBLIC HEALTH

Sherrie Patch, Carbon County Public Health Nurse presented a perinatal contract for the Commissioners consideration.

CLERK OF COURT

Lindy Smith, Clerk of Carbon County District Court told the Commissioners about remodeling she would like to see done.

ROAD & BRIDGE

Paul McCarthy of PMPC Consulting Engineers, gave a summary of costs to repair the Sanger Bridge (\$17,014.14).

A motion was made by Graalman, seconded by Fleming and carried to give a portion of a 0.37 acre tract of an acre tract of land located in the NE $\frac{1}{4}$ NW $\frac{1}{4}$ and NW $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 8, Township 12 North, Range 90 West of the 6th P.M., Wyoming; said .37 of an acre tract being described in Book 104 at Page 387 of the Carbon County records; said tract being more particularly as follows:

Beginning at a point on the North line of Section 9 in Township 12, North of Range 90, West of the 6th p.m., 2553.7 feet West of the Northeast corner of Section 9; running thence South 320 feet, thence West 50 feet; thence North 320 feet, thence East 50 feet to the place of beginning containing thirtyseven hundredths of an acre, and situate in the Northwest quarter of the Northeast quarter of said Section 9 in Township 12 North of Range 90 West of the 6th p.m., in Carbon County, State of Wyoming.

A motion was made by Graalman, seconded by Fleming and carried to transfer a 1985 Dodge pickup truck (V.I.N. 1137KD34WXFS586233) for one year or the termination of the program to the VISTA program.

FAIR TROPHIES

A motion was made by Fleming, seconded by Graalman and carried for the Commissioners to donate Grand Champion Market Steer, Lamb and Hog trophies for the 1992 Carbon County Fair.


ROAD & BRIDGE
