Shirley Bye-Jech, representing the Bureau of Land Management, discussed the back country by-ways program and requested the Commissioners cooperation with the federal program. The Board agreed to cooperate and the Road & Bridge department will help with signing.

Gene McMillen and Susan Grafton, representing the County Planning Commission discussed possible zone changes in the Ryan Park area. Also presented were the Administrator's Report for the month of February, 1991, and an update from the Miracle Mile Planning Group.

ECONOMIC DEVELOPMENT

Gene McMillen representing the Carbon County Economic Development Corp., updated the Commissioners on current projects of that corporation.

FIRE DEPARTMENT

Dan Schinkle and Dwight France of the Carbon County Fire Department discussed the need of a vehicle to transport fire personnel. Schinkle reported on the Fire District meeting.

Don Neuman, County Road Supervisor, presented the bill from David L. Holt Co., Inc. for the repair of Butler Bridge (\$14,841.00). Also discussed was the purchase of fuel from Wyoming Surplus Property & the disposal of county equipment used by Road & Bridge.

The Commissioners told Neuman to send three men to Casper to a geotechnical school.

Clayton Kilgore, Carbon County Radio Tech, discussed dispatching for the hospital and 911 services.

OLD PEN

Dr. Bauman, Margaret Brown, Roger Vagner and Tom Wagenknecht requested the county pay one half the wages of a full time position at the Old Pen. The City of Rawlins would pay the other half.
