A RESOLUTION AMENDING RESOLUTION NO. 1990-5
CREATING PERSONNEL POLICIES AND PRACTICES FOR
THE CARBON COUNTY COMMISSIONERS.

WHEREAS, the Carbon County Commissioners find it necessary to amend the resolution described above by the addition of the following language,

NOW, THEREFORE, BE IT RESOLVED BY THE CARBON COUNTY COMMISSIONERS, that the following sentence shall be added to the end of Section 4. HOURS OF EMPLOYMENT:

Nothing contained herein shall conflict with the Fair Labor Standards Act, which Act shall in all cases prevail.
