A motion was made by Graalman, seconded by Fleming and unanimously carried to have Richard Gregory, Bill Harshman and Don Neuman come up with a plan to dispose of county owned buildings in Hanna. These buildings were received by the County through tax deeds.

PLANNING

Nina Adams, County Planner presented her administrator's report for the month of October 1992 and reported on the Planning Commission meeting held earlier in the day regarding Cherokee Ranch and Baggot Rocks.

EXECUTIVE SESSION

A motion was made by Fleming, seconded by Graalman and carried to enter into executive session to discuss litigation.

A motion was made by Fleming, seconded by Graalman and carried to end the executive session and resume the regular meeting.

AMOCO

After extensive discussion the terms of settlement proposed by Amoco were found to be less advantageous than the ultimate result should Carbon County lose the pending litigation and it appears to be in the best interest of citizens of Carbon County that the Commissioners refuse the Amoco offer.

A motion was made by Graalman, seconded by Fleming and unanimously carried to reject the Amoco offer.

ROAD & BRIDGE


County Road & Bridge Supervisor, Don Neuman discussed bridge repairs, snow removal at Ryan Park and the disposal of a truck.

The Commissioners agreed to the disposal of a 1977 Ford 3/4 ton truck for \$250. The truck formerly had a welder mounted on it; the welder will be removed before the truck is sold.
