PLANNING

County Planner, Nina Adams gave her administrator's report for the month of July.

A motion was made by Graalman, seconded by Fleming and unanimously carried to approve the following:

Case File No. 93-03 - Amendment - Carbon County Planning Commission, P.O. Box 487, Rawlins, Wyoming, 82301. To amend the Carbon County Zoning Resolution of 1972, specifically Section 300, Subsection 310, Item 312, to add new item 312.9 under Special Permit Uses for commercial wind farms consisting of wind towers or other appurtenant items and related facilities with proof of permits; and, to include the definition of commercial wind farms under Section 600.

Case File No. 93-08 - Amendment - Carbon County Planning Commission, P.O. Box 487, Rawlins, WY 82301. To amend the Carbon County Zoning Resolution of 1972, specifically Section 530, Subsection 533, to change this subsection to read "Zoning Permit Fees - Set by the Planning Commission and reviewed on a regular basis."

FIRE DEPARTMENT

County Fire Warden, Dan Schinkel and County Fire Chief, Dwight France presented a new mutual aid agreement with BLM.

ROAD & BRIDGE

County Road & Bridge Supervisor, Don Neuman gave his administrator's report.

The Commissioners signed a right of way easement on and for Carbon County Road #340 between Carbon County and John W. Swanson.

The Commissioners signed a right of way easement on and for Carbon County Road #501 between Carbon County and Edward Nicholson.

The Commissioners signed a project agreement for SC-CFM 6-47 to survey and map the Jack Creek Road (County Road #500).


The Commissioners signed a letter concerning the Elk Mountain Shop sewer line to the Wyoming Department of Transportation.
