RESOLUTION 1993 - 14

A RESOLUTION OF THE CARBON COUNTY COMMISSIONERS AUTHORIZING THE COUNTY OF CARBON, BY AND THROUGH ITS COMMISSIONERS, TO SUBMIT AN APPLICATION FOR A GRANT FROM THE STATE OF WYOMING COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM AND CERTIFYING THAT ALL PUBLIC PARTICIPATION REQUIREMENTS HAVE BEEN MET.

WHEREAS, public notice of the public meeting to discuss the application for a Community Development Block Grant was published seven days prior to the hearing and informed citizens of the dollar amount available, the range of allowed activities and other pertinent information, as well as provided information concerning the time and location of the hearing; and

WHEREAS, the improvement and modification of certain elevators in Carbon County buildings will provide better access for those individuals in groups meant to be assisted by the Americans With Disabilities Act, and that such improvement is necessary to bring the aforescribed elevators into compliance with that federal legislation; and

WHEREAS, access to Carbon County government and Carbon County programs being of upmost importance to the Commissioners, and compliance with federal legislation is necessary;

WHEREAS, the Carbon County Commissioners wish to obtain a CDBG Grant for purposes of upgrading elevators in the Senior Citizens Center, the Jeffrey Center, the Carbon Building and the Carbon County Courthouse;

NOW, THEREFORE BE IT RESOLVED, that the Carbon County Commissioners on this day, September 7, 1993, hereby endorse the application for a CDBG Grant and hereby approves the application for submittal to the Wyoming Economic Development and Stabilization Board for their consideration.

A motion was made by Fleming, seconded by Graalman and unanimously carried to appoint Edwin Reed to the Baggs Solid Waste Disposal District.

PLANNING PUBLIC HEARING

A motion was made by Fleming, seconded by Graalman and unanimously carried to approve the following:

Case File #93-05 - Zone Change - Floyd E. Roberson, P.O. Box 687, Riverside, WY 82325. A Zone Change from RD-5 (Residential Development 5 acres) to HB (Highway Business) to allow for rental storage buildings to be constructed on two parcels legally described as Lots 1 and 4 of the Arapaho Flats Subdivision in the E½NE¼NE¼ of Section 5, Township 14 North, Range 83 West, Carbon County, Wyoming.

The Commissioners signed a right-of way easement between Josephine M. Salisbury and Carbon County for County Road #501.


The Commissioners signed a right of way easement between Janice Loerch and Carbon County for County Road #501.
