EMERGENCY MANAGEMENT

County Emergency Management Coordinator, Nick Casson met with the Commissioners to discuss the Town of Elk Mountain. The Town of Elk Mountain has declared a state of emergency.

A motion was made by Fleming, seconded by Graalman and unanimously carried to declare a state of emergency through adoption of the following resolution:

R E S O L U T I O N 1 9 9 3 - 5

WHEREAS, Carbon County is anticipating damage to roads, bridges, culverts, farmlands, homes, businesses, and other public facilities caused by expected high level of moisture content from the Medicine Bow River leading into the Town of Elk Mountain transpiring sometime this spring of 1993.

April 20, 1993

WHEREAS, the cost of cleanup, repair and placement of such proper facilities to protect from the high water damage from the Medicine Bow River, is in excess of County resources available.

NOW, THEREFORE, BE IT RESOLVED that the Board of Carbon County Commissioners of Carbon County, Wyoming, declare this to be a disaster area.

PUBLIC HEARING

A public hearing was held on a transfer of funds in the amount of \$10,000 from the Carbon County General Account to the County Clerk Election budget.

A motion was made by Graalman, seconded by Fleming and unanimously carried to transfer the funds.

MEMORIAL HOSPITAL OF CARBON COUNTY

Sarah Thornton of the Memorial Hospital of Carbon County asked the Commissioners to give the hospital more consideration in the budget.

C.O.V.E.

Ramona Sandoval of C.O.V.E. requested the Commissioners proclaim the week of April 25, 1993 through May 1, 1993 as National Crime Victim's Rights Week.

A motion was made by Graalman, seconded by Fleming and unanimously carried to make the proclamation.

RATTLESNAKE PASS ROAD

A motion was made by Fleming, seconded by Graalman and unanimously carried to authorize Carolyn Duncan to look for grants to upgrade the Rattlesnake Pass Road.

ROAD & BRIDGE

The Commissioners signed a letter to Lowell Fleenor, Wyoming Highway Department regarding SC-CFM 6-30 project Sanger Bridge and stopping SC-CFM 6-30 Sanger Bridge repairs.

The Commissioners signed a letter to Lowell Fleenor, Wyoming Highway Department regarding SC-CFM 6-44 Seminoe Dam Road fencing project.

The Commissioners signed a letter to Lowell Fleenor, Wyoming Highway Department concerning the final plans and cost for SC-CFM 6-40 Sage Creek & Jack Creek Road projects.

The Commissioners signed a change order for additional services on SC-CFM 6-40.

UPPER PLATTE RIVER SOLID WASTE DISPOSAL BOARD

The Commissioners signed a resolution allowing the Upper Platte River Solid Waste Disposal Board to acquire federal surplus property from Wyoming Surplus Property at their own expense.

The Commissioners also signed a resolution to allow Dwight France, Clayton Kilgore, Chester Engstrom, Jerry Colson, and Donald Neuman to acquire property from Wyoming Surplus Property for their respective departments.

CARBON COUNTY SENIOR SERVICES, INC.

The Commissioners signed an extension of lease agreement with Carbon County Senior Services, Inc. for use of the various senior centers throughout the county.

MINERAL PRODUCTION

The Commissioners signed a letter of support for the Proposed Amendments/Statement of Reasons, Chapter XXI, Ad Valorem and Severance Taxes on Mineral Production.
