BUDGET AMENDMENT

A public hearing was held at 11:30 a.m. regarding the amendment of Carbon County Museum and Carbon County Library budgets.

A motion was made by Fleming, seconded by Graalman and carried to approve the following:

R E S O L U T I O N 1 9 9 4 - 7A RESOLUTION AUTHORIZING AMENDMENT OF THE COUNTY BUDGET
FISCAL YEAR 1993-94

WHEREAS, due to requirements that were not reasonably foreseeable at the time the budget was adopted, it became necessary to transfer \$4,364.60 from the Carbon County General Fund to the Carbon County Museum budget.

WHEREAS, the Carbon County Museum has received \$375.00 in unanticipated revenue to be used within the fiscal year 1993-94 budget.

WHEREAS, the Carbon County Library has received \$58,403.00 in unanticipated revenue to be used within the fiscal year 1993-94 budget.

WHEREAS, notice was published on June 14, 1994 in the Rawlins Daily Times of the public hearing to amend the budgets of the Carbon County Museum and Carbon County Library as required by statute.

WHEREAS, the public hearing was held June 21, 1994 at 11:30 a.m. in the Commissioner's Meeting Room of the Courthouse, Rawlins, Wyoming to hear protests regarding the proposed amendments.

WHEREAS, there were no protests received during the public hearing regarding said proposed amendments.

NOW, THEREFORE, IT IS HEREBY RESOLVED, that the amount of \$4,364.60 be transferred from the Carbon County General Fund to the Carbon County Museum budget to supplement the aforementioned budget.

NOW, THEREFORE, IT IS HEREBY RESOLVED, that the Carbon County Museum budget for fiscal year 1993-94 be increased by \$4,364.60 for funds received from the County General Fund and \$375.00 for unanticipated funds received, the total amendment being \$4,739.60.

NOW, THEREFORE, IT IS HEREBY RESOLVED, that the Carbon County Library budget for fiscal year 1993-94 be increased by \$58,403.00 for unanticipated funds received.
