PERSONNEL

County Civil Attorney, Wade Waldrip and Deputy County Clerk, Teddy Yockey met with the Commissioners to discuss updating the County's personnel policies and scheduling employee/supervisor workshops. The Commissioners agreed to the update and scheduling of the workshop.

CERTIFICATE OF PURCHASE

The Commissioners completed an assignment of certificate of purchase for lots 22 & 23 of the 3rd South Side Addition, City of Rawlins to David Martinez.

LAND USE

Jack and Nina Parkhurst gave a presentation on the history of land use.

CARBON BUILDING

Representatives of Johnson Controls presented a contract for maintenance of the Carbon Building heating/cooling system.

A motion was made by Graalman, seconded by Fleming and unanimously carried to void the previous contract and enter into the new contract with Johnson Controls for maintenance of the Carbon Building heating/cooling system at a cost of \$6,900.00, repairs to be paid outside of contract for the period beginning August 15, 1994 and ending August 15, 1995.

Johnson Controls advised the Commissioners that the Carbon Building compressor units were destroyed due to an electrical power surge or failure. The Commissioners directed a letter be written to Pacific Power requesting financial relief for the compressor replacement due to electrical power surge or failure.

The Commissioners requested an estimate for compressor replacement be prepared by Johnson Controls and presented at a later meeting.

PUBLIC LAND SALE HEARING

Jim Whalen and Jeff Winestein of the State Land Office conducted a hearing to receive comments from concerned citizens regarding the possible sale of public lands in Carbon County. The parcels being considered for sale were nominated by the Silver Spur Ranch, P H Livestock and Double 8 Ranch.

PLANNING

A public hearing was held at 2:00 p.m. regarding Case File #94-09.

A motion was made by Graalman, seconded by Fleming and carried to table action on Case File #94-09 until the September 6, 1994 meeting. The file reads as follows:

Case File #94-09 - Zone Change - Dennis DaDante, 63 West Fifth Avenue, Berea, OH 44017. A Zone Change from RAM (Ranching, Agriculture, Mining) to two RD-5 (Residential Development - 5 acres) zoning designations on two subdivision parcels to allow for residential development. The parcels are legally described as Lots 22 and 25 in the Aspen Highlands #1 Subdivision, lying in the NE $\frac{1}{4}$ SE $\frac{1}{4}$, NW $\frac{1}{4}$ SE $\frac{1}{4}$; NE $\frac{1}{4}$ SW $\frac{1}{4}$; SE $\frac{1}{4}$ NE $\frac{1}{4}$, SW $\frac{1}{4}$ NE $\frac{1}{4}$; and SE $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 10, Township 19 North, Range 81 West, Carbon County, Wyoming.

FAIR BOARD

A motion was made by Fleming, seconded by Graalman and unanimously carried to purchase a truck for the Fair Board.

BAGGS SOLID WASTE DISPOSAL DISTRICT

A motion was made by Fleming, seconded by Graalman and unanimously carried to re-appoint Agnes Stocks to a second term on the Baggs Solid Waste Disposal District Board. The term is for three years.

A motion was made by Fleming, seconded by Graalman and unanimously carried to appoint David A. Danford to a three year term on the Baggs Solid Waste Disposal District Board.

SARATOGA-ENCAMPMENT-RAWLINS CONSERVATION DISTRICT

A motion was made by Fleming, seconded by Graalman and unanimously carried to approve the Saratoga-Encampment-Rawlins Conservation District petition requesting an election. The petition requested a one mill levy.
