COUNTY PROPERTY

Pam Farster with the Rawlins Downtown Development Association inquired about the status of the old Silver Spur building owned by the County.

LIQUOR LICENSE

A public hearing was held for the transfer of a retail malt beverage permit from Frank E. or Roberta M. Erickson d/b/a 3 Forks Muddy Gap Service to Teressa Norton d/b/a Three Forks Muddy Gap.

A motion was made by Fleming, seconded by Graalman and unanimously carried to approve the ownership transfer.

A public hearing was held for the transfer of a retail liquor license from Patsy A. Payne d/b/a The Place located in a log building along Highway #130 in the SE $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 18, Township 16 North, Range 81 West of the 6th P.M. to Daniel Davidson d/b/a/ Daniel Davidson located in a building to be constructed $\frac{1}{2}$ mile south of Saratoga on the East side of Highway #130 in Township 17 North, Range 84 West, Section 24 NW $\frac{1}{4}$ NW $\frac{1}{4}$.

A motion was made by Fleming, seconded by Graalman and unanimously carried to approve the transfer of owner and location.

ROAD & BRIDGE

County Road & Bridge Supervisor, Don Neuman gave his administrator's report.

The Commissioners signed a right-of-way and utility certificate for the Seminoe Dam Road project STPC 6-44 with the Wyoming Department of Transportation.

The Commissioners signed a letter to Joe Yovich, District Engineer for the Wyoming Department of Transportation, stating that they are in agreement and support the moving of the bid date for STPC 6-44, Seminoe Road Project to June 9, 1994.

The Commissioners signed a cooperative agreement for the preliminary engineering, right of way acquisition, utility adjustment and construction on the county roadway system with the Wyoming Transportation Department for the Seminoe Dam Road Project STPC 6-44.
